## **Officer Written Reports**

## President/Josh Coy.82

#### SAGE fall summit

- Great experience working with other large land grant universities and sharing best practices. Many valuable discussions were had, and new relationships formed.
- The long term SAGE advisor is UT Austin's Legislative Director Ellyn Perrone. Ellyn also was OSU's LD under President Holbrook, and founded the current DC office for OSU, as well as hired our current DC lobbyist. She is very pro-OSU and this is a welcome added bonus to our renewed relationship with SAGE.
- Legislative platform for DC will primarily be surrounding Immigration,
   Student Debt, and Research. The issues surrounding research funding
   were discussed in detail and will be addressed in any white paper created.
   Chloe will be helping to draft this portion of the platform.
- We expect to pitch OSU as next year's location for the SAGE fall summit, and I have begun reserving rooms for next year (around the Oct 24th weekend) in preparation for this. This would be a great opportunity for many CGS members to get involved with SAGE.

#### Highball Halloween

- Highball appears to have been a success, all tickets were sold out in advance of the event.
- However, due to repeated problems with communication and negotiations with the SNA, it is recommended that neither CGS or OUAB repeat this event for a 3rd year.

#### GCBC

- I've been working to accumulate the necessary data for the committee and the HR dept is currently compiling this.
- Also requested the cost associated with the possible next round of 3 yr increases from assoc Provost Brad Harris. Response was:
- "The Graduate School helped with an analysis to answer your question about the cost of implementing an increase to the grad minimum stipend of \$1,500/year for 3 years. The cost is estimated to be \$5.7 million over the three year period.
- o The incremental cost per year is:

- Year 1 \$1,179,423
- Year 2 \$2,214,435
- Year 3 \$2,298,961"
- This level of cost is quite reasonable and in fact much lower than I expected.
- South Campus Gateway Expansion

  - We had been led to believe that Campus Partners were far from deciding on a developer, but this does not seem to be the case, though no official announcement confirming this developer has come from CP yet.

## **Diversity & Inclusion, Campbell.1651**

- We are going to sponsor an event with a graduate student organization, the Christian Graduate Student Alliance (CGSA), that will likely take place in January. This event will feature an "inter-faith panel" with an open discussion about different faiths, beliefs, and perspectives and their relationship to academia and being a graduate student.

## **Governmental Relations, Tull.20**

#### INTRODUCTION:

 After arriving back from the Student Advocates for Graduate Education (S.A.G.E.) Fall Summit at Texas A&M University in College Station, Texas the Governmental Affairs Committee has several national issues to report out regarding. In addition, several other national issues have come to our attention.

## • S.A.G.E. ISSUES:

- After meeting with our partner universities for three days at A&M, four main issues affecting students emerged as key. They included Indebtness and Taxation; Immigration; Research Funding; and Sexual Assault.
- O Indebtnenss and taxation affect graduate students on a national level. Currently, those in politics expect an Omnibus bill to pass that will allow for provisions protecting graduate student stipends from unreasonable taxation. An omnibus bill is expected to "provide specific funding levels for federal agencies and programs." Many anticipate this will serve students better than the passage of a Continuing Resolution (CR), of which the current CR will expire on December 11, 2014.
- Immigration exists as an issue for SAGE as it pertains to the STAPLE Act. S.A.G.E. supports the idea that we want foreign-born, but U.S. educated graduate students to stay here upon graduation. This pool of individuals are categorized as possessing "highly skilled labor" and seen as vital to the U.S. economy.
- Research Funding is an issue on the agenda for S.A.G.E. In addition, the issue of National Science Foundation (NSF) was discussed at our fall summit. It seems that the contention that proposals in the humanities are being rejected at higher rates does in fact prove correct. The Ohio State University has partnered with Rutgers University and University of North Carolina-Chapel Hill to investigate and look further into research funding in general and how S.A.G.E. can support research and scholarship. Please let me know if you want to be included in this conversation!
- Sexual Assault is also an issue that S.A.G.E. is discussing. It is the newest issue added to their list of topics as it pertains to graduate education and graduate student experience.

#### NATIONAL ISSUES:

- A number of national issues are affecting graduate students, and the main ones include an amendment to the Higher Education Act of 1965 and the addressing of sexual assault by the Department of Education.
- The Higher Education Act of 1965 has recently been amended to promote an "accountability framework" in terms of the creation of Gainful Employment Regulations. These regulations seek to increase

- transparency in costs of education, student debt, earnings, and completion at nearly all educational establishments.
- The Department of Education (DOE) has released its final version of its rules governing the prevention and handling of sexual assault. These regulations fall under the Clery Act, the legislation that handles sexual assault on college campuses funded by the DOE.

- Ohio State looking to move toward Comprehensive Energy Management:
  - Leasing Our Energy infrastructure to a private entity that would operate our energy assets.
  - Energy Conservation Measures: The same partner also would be responsible for funding and accomplishing energy conservation measures campus-wide, providing an opportunity to make significant gains toward Ohio State's aggressive sustainability goals.

- Energy Supply: This partner would use its industry expertise and Ohio State's purchase power as one of the single largest utility customers in the state of Ohio to get the best deal on purchasing our energy supply in the long-term.
- Affinity: The university also would investigate opportunities with this
  partner to attract funding to bring students to Ohio State and provide
  scholarships and internships, as well as opportunities for funding research
  and collaboration with faculty and students.
- The first step in this process would be to Issue a Request for Qualification (RFQ), by the University. All RFQ's will be evaluated by the Presidents and Provost's Council on Sustainability to ensure all key stakeholders are being represented. University is going to keep key stakeholders involved in this process by ensuring that all information is released in a timely manner as deemed appropriate.

## **Officer Written Reports**

## President/Josh Coy.82

- Treasurer David Rochman has resigned from his position.
  - Michael will update all on the coming elections procedures to fill his vacancy.
- Our esteemed advisor, Kerry Hodak, is back from maternity leave.
  - Great to have Kerry back!
- The Career Center is putting on a grad school expo on October 21st that CGS is cosponsoring. If you are interested in helping out, contact me.
- Highball wrist bands are now available! Students are able to receive 2, but must specify the days you want to attend. So, you can get two for either Friday or Saturday, or one for each. I will be out of town for the event this year, so would welcome hearing opinions from those of you that do attend.
- Michael and I met with the Provost and HR offices.
  - The Provost indicated that the primary support for increases in grad stipends recommended by GCBC would come first from the Graduate School. Meetings are being scheduled for Michael and I to meet with Dean Osmer shortly.
  - GCBC is to meet for a rescheduled first meeting on 10/17. I look forward to hearing from the new chair and discussing their plan for this year.
  - O HR meeting was informative. They consider the parental leave "generous" and do not support an increase in paid leave for adoptive parents for faculty/staff. They seemed willing to consider additional unpaid leave for graduate students, likely due to the low cost of such a policy change, as well as the reasonable argument that funded graduate students do not have vacation or sick time to pull from.
  - I spoke with Dr. Drake about our request and he was going to discuss with HR driectly himself.
  - There is a possibility that HR will want more benchmarking data, and if that becomes the case, I intend to request that GCBC take this issue on more directly, since this issue should fall under their purview as a benefit if the discussion continues any further.
  - The discrepancy between the actual policy and what has been reported to The Dave Thomas Foundation has been corrected as a result of CGS pointing it out.

- SAGE Conference will take place Oct 23rd-26th in College Park, TX. CGS members attending are Josh, David B, and Chloe. We look forward to reporting back on the trip and helping the governmental relations committee fine tune their goals for this year.
- 5hr requirement issue for GTAs. This issue may better be informed after we have more survey data, but I have asked the depts affected to first discuss amongst their local student orgs regarding what specific issues they have. It is important to remember that employment in Ohio is "at will" so you can be required to carry other duties if you are not working a full 20 hrs from your primary assignment. However, there are issues of how the determination that teaching one class equals 15hrs, and the equity of the way in which assignments with different levels of effort are distributed. On the other side, students must also be able to show that it actually does take 20 hrs to teach a class if they are going to argue against an additional 5 hr requirement. More as this develops.
- I will be advocating for a change in the student code of conduct to include affirmative consent. This is in the beginning stages of development, but Dr.
   Drake approved of such a path, and I hope to involve all student governments in this effort.
