QUALTRICS Switch

- The university is currently switching over to a comprehensive site license for qualtrics for the entire university and will have a university log in portal for OSU students. This means that students will use their OSU log in and password to access qualtrics instead of a separate qualtrics account.
- This switch has already taken place for some departments. During this
 process Qualtrics is unavailable for up to 24 hours. After this switch you
 then need to go to osu.qualtrics.com to log in to your account.
- At least for my department there was no communication about the switch or the new website to access qualtrics. Because of this I have been in contact with individuals at OCIO to understand the switch and how it will affect departments. It seems they planned for the switch to all happen at once but instead is happening one department at a time. So it is important to know that your qualtrics account may be down for a period due to "site migration" If you see this notification, this is what is happening. It may also say "invalid brand" when you try to log in. Both of these are indications that the switch is taking place and you will have to use osu.qualtrics.com to log in.
- I hope to meet with the representatives at OCIO next week to get more specific information to share with your departments and hopefully understand a timeline of when this switch will happen so departments will be aware.

- Be sure to forward news updates to your departments when I send them out so
 information gets to all students (look for one once classes get started back up).

Standing Committee Written Reports

Academic Relations, Holowacz.1

- Committee of Academic Affairs
 - Meeting for 2/18/15 was cancelled. No Updates
- Appointment Survey
 - o In an effort to improving your experience as graduate students, a survey is being constructed that focuses on the duties associated with appointments. Since there are a number of possible financial changes coming to OSU (specifically the College of Arts and Sciences), it was seen as beneficial to obtain specific information on each term and appointment as opposed to an overall experience.
 - Meetings are being scheduled to POSSIBLY incorporate a portion of the questions into a larger graduate student survey.
- Supplemental Insurance
 - There was some concern regarding the requirement for graduate students to purchase supplemental travel insurance when traveling abroad, regardless if they are insured through OSU. I have done some investigating and here is a summary of my findings.
 - The insurance is there to benefit both, OSU and its students. When OSU allows students to travel abroad, OSU implicitly assumes some of the risk involved with travel. Therefore, in an emergency, OSU would be challenged to exercise its duty of care and respond on the traveler's behalf. This response may have financial ramifications if responded to properly. If not responded to properly, OSU faces possible legal ramifications. The supplemental insurance provides comprehensive medical insurance with no deductible, a network of partner facilities and evacuation. Payment for this insurance provides the infrastructure for the international emergency response protocol. Without this insurance, OSU may face potential ethical, financial, legal, and social issues. With this insurance, travel to high risk destinations, such as Algeria and Haiti are made possible, and allow for both parties to remain protected.
 - The policies and procedures set forth by the International Travel Policy Committee (ITPC) were benchmarked against peer institutions. Therefore, policies, operating procedures, and the specific elements of the insurance coverage itself are comparable to other institutions. For example, while the requirement of supplemental insurance is not universal, Michigan, Minnesota, and Texas, have similar policies in place.

 Unfortunately, there have been instances in the past where graduate students did travel abroad and did not have supplemental insurance.
 Luckily, there have been cases where OSU was able to enroll them in the nick of time. It seems that the ITPC would like to prevent such cases from happening again.

 - Here is some information about the Open Doors Program from their website:
 - Open Doors is a 4-hour training broken down into three conceptual modules, each teaching a unique aspect of responding to bias. The intent of this program is to create a safer and more welcoming environment which acknowledges that acts of bias occur at our University and which helps individuals and communities heal from, and become more resilient to, acts of discrimination and bias. By agreeing to become an Open Doors Partner, the participant agrees to undergo training and to serve as a resource for people seeking help in reporting acts of bias.
 - After the training sessions a participant will receive resource materials about bias and diversity and an Open Doors Insignia to denote that she/he has completed the bias training and is an Open Doors Partner. The Open

- Doors Insignia is a symbol to all people who have experienced an act of bias that you are an understanding, supportive, and trustworthy individual. Witnesses or victims of bias will know that they can come to you as an ally for help, advice, or just to talk with someone who is supportive of their well-being.
- The Open Doors Insignia also means that biased and discriminatory comments and actions will not be tolerated; they will be addressed in an educational and informative manner. The message that the Open Doors program will send out is one of understanding, non-judgment, and knowledge of the concerned parties' needs and experiences. It is symbolic of the willingness and commitment on the part of a community to provide an atmosphere of unqualified acceptance and assistance.

International Student Concerns, Anderson.2299

• The ISCC has been working diligently on the following issues:

- OSU's 30+ participating international student organizations, the Ohio Union, and the Office of International Affairs hosted another wonderful, delicious, successful Taste of OSU. We are a diverse, colorful community of Buckeyes! http://thelantern.com/2015/02/a-taste-of-osushows-a-taste-of-the-world/
- If you are an international student and have received a citation for driving with a valid foreign license and not an Ohio license, please email both Roger Anderson (Anderson.2299@osu.edu). We are trying to gather data on the importance of this issue.
- We will be meeting with Nancy Thompson from Buckeye Careers. We are interested in making the career fairs friendly for international students.
- We will be meeting next week with staff and advocates of sexual violence prevention education in order to craft and implement a workshop specific to international students. Sexual violence affects domestic and international students of all genders on this campus. We hope that this workshop will take place Spring 2015. More info forthcoming.
- We helped to facilitate information for two recent cases of international studentds facing COAM (Academic Misconduct) charges.
- We are in communication with the Wilce Student Health Center administrators regarding mandatory international student check-ins. Our interest is that international students do not have unpleasant experiences in checking in, particularly on the first hot August days of Autumn. Due to the Wilce Center renovations, the Spring 2015 check-ins occurred in the RPAC Center. Because of the difficulty in transporting medical equipment, etc., Wilce staff is committed to hosting the large Autumn 2015 check-in (health screenings) in the Wilce Center (rennovations are scheduled to be completed in time.
- We have been focusing heavily on seeking clarification on Ohio's driving laws regarding international students who hold valid foreign driver's licenses, and on advocating for locating space and extending liability coverage for international students and their family members to practice for the mandatory maneuverability portion of the Ohio driver's exam. Currently, practice driving is not permitted within OSU's vast parking lots.
- Pursuant of these two goals, the committee has been in contact with the following OSU departments and community actors. Details of such work has been intentionally suppressed in the interest of time/ space.

- cheating on an exam, you should not take the exam away (you can move the student or take phone away, etc) but you should record the evidence and submit the case to COAM.

- As mentioned before, the University is looking to privatize its utilities. Presently, an RFQ (Request For Qualifications) is being sent out, to the general public, to gather interest. Interested parties can then express interest by providing a Statement of Qualifications to the University. The team can propose part of the opportunity available for the project (for example, a potential party can propose looking at maintenance of the utility system, and not want to maintain and implement any energy conservation measures). All RFQs will propose their financial model, which will be evaluated by the University. All parties are allowed to propose a financial model that work best for them. All RFQs have to submitted by April 6, 2014.
- Ohio State is looking to start a bike sharing program. Bicycling represents
 approximately 8% of on campus transportation with an annual growth rate of 1%.
 Reducing motorized vehicle transportation by increasing bicycle use is consistent
 with Ohio State's climate commitments, the university Framework Plan, and Ohio
 State's interest in improving the health of its populations. They project has
 money dedicated to the program from several colleges and the PPCS, and they
 are waiting on another funding source before further action.

- This year's Zero waste Initiative has reached an all-time high! The highest diversion this year was 98.7% for the Indiana game.
- The President and Provost's Council on Sustainability recently approved \$50,000 in funding to move forward with a zero-waste program at the Schottenstein Center. These changes will allow the Schottenstein Center to achieve a zero-waste rate of 70 percent at the end of the first year of the program, compared to the rate of 21 percent from Fiscal Year 2014.
- The Marion Campus has reached its goal to be a Zero Waste campus in its first year! The zero waste program began as a pilot program, and was adopted officially by the campus in July 2014. Prisoners at the Marion Correctional facility sort the material at the correctional facility recycling center to remove any contaminants from the waste, and to remove and reduce as much material as possible from the waste stream to the landfill.

University Area Commission, Odden.2

- University Area Commission
 - Reported on behalf of graduate students who experienced what was perceived as police overreach and overreaction the night of the National Championship game -- including a rifle pointed at a student's face, tear gassing and macing. Reception by the Columbus Police Department (CPD) representative and some non-student members of UAC was not positive. CPD Internal Affairs is conducting an investigation and we are invited to submit reports there (please report to odden.2@osu.edu first, and CGS will submit a collated report).
 - The Mayor and City Council have charged CPD Chief Kim Jacobs with drafting a report of recommendations for Columbus Public Safety Director George Speaks to address policing in Columbus. Five community forums will be held, dates and locations TBA.
 - Some traffic lights on Summit St and N 4th St may go away. UAC/CGS will have representation on a Columbus Traffic Division committee to provide input on this decision.
 - COTA is making service changes in response to its 2014 Transit System Review -- see www.cota.com/transitsystemreview.aspx for details. UAC plans to advocate for the 'CBUS' connector to extend further North to make the free downtown connector service more accessible to OSU.
 - The Comprehensive Transportation and Parking Plan brings a variety of changes, some dramatic, to the traffic landscape at OSU. See http://ttm.osu.edu/sites/default/files/attachedfiles/ExecutiveSummary_CTPP_2014.pdf for details.


