1.1. Campus Connections with Dean Mary Stromberger of the Graduate School

1.1.1) Students who are already at OSU are now eligible for fellowships (OSU undergrads to OSU grads)

1.1.2) Increase in graduate associate stipends and postdoc salaries approved

1.1.3) Leadership is in four different teams: academic excellence, grad student experience, grad and postdoc training, operations and strategic initiatives

1.1.4) Commitment to diverse student body despite Supreme Court rulings on excluding race and ethnicity to admissions decisions

- Increase retention and reduce gaps for diverse students so all students can be supported
- All grad programs statistics: Non-underrepresented minorities (URMs) declined admit rate 4%, URMs declined admit rate 6.5%
- PhD programs statistics: URMS declined admit rate 8.1%, White students declined admit rate 3.1%
- Of students accepted, URMs enrolled much more so the number of URM students have stayed the same despite the declining admission rate
- Looking at policies and practices that disadvantage students
- 1.1.5) Academic Competitiveness
  - Looking at fellowships and making sure they're equitable since not all doctoral students can be funded by fellowships
  - GRA min stipend increased, fellowship stipend may have increased as well
  - Running out of rainy day fund (OSU had extra money and so has been using it to fund graduate students), so need to start fundraising in order to combat the rising stipend costs with declining extra funds, going to start fundraising

1.1.6) Graduate Office student survey going out at the end of the year to help look at these issues 1.1.7) Q+A

Q: Unknown CGSer: Where's the funding increase for stipends going to?

A: Retaining students for emergency funds, dissertation fellowships, interdisciplinary Program

Q: Carerra.55: Did the acceptance rate of non-URMS decrease as well?

A: It did decrease slightly because of the number of slots and lack of funding. Reaching out to admissions committees to see what their situations are. Race and ethnicity isn't allowed to be talked about in admissions. People will be cautious if they disclosed their race and ethnicity because if accepted, OSU could be accused of accepting someone based upon on their race and ethnicity.



Q: *Unknown CGSer:* How many PhD students don't have any funding period? A: I'm not aware of any programs where none of their PhD students are funded.

Q: *Unknown CGSer:* The 18% stipend increase is divided into 4 or 3 years of increasing. Why is it divided by that and those gaps? Also, 18% in 4 years isn't enough for inflation, what are the arguments for not getting more funding? How is the minimum stipend enforced across the colleges? Some programs have received less fellowships than before, and the University re-distributed these fellowships. How do we break this cycle? A: There are financial squeezes happening. As stipends increase, there will be fewer GRA and fellowships slots. We did an allocation based upon PhD enrollments. We looked at what departments had the most PhD slots. Those departments with the most got more while other departments got cut. The 18% increase was done on an analysis for the livable wage for Columbus. The university agreed to a 5% increase for one year. There needs to be an incremental increase every year. The university has not made a decision for the increase on minimum stipends for next year.

- 9.1. Delegate Issues and Concerns
- 9.1.1) Sharing the Delegate Playlist
  - Elton.21: Is there a way to share past delegate playlists?
  - Robinson.2283: Yes, we can find a way to share past delegate playlists.

#### 9.1.2) 12 Month Payback for 2025 Education Benefit

- **Oteng.12**: There's been a change to the Fall 2025 education benefit program that essentially requires at least 12 months of post degree completion of service to maintain employment to the university or the employee will be made to repay their education benefit from the previous year. I was wondering how this change came about and how many grad students does it effect? This policy seems to operate as a chain to the university and was wondering why we have to pay it back?
- **Durso.19**: Joey, quick question does this policy only pertain to your department or the whole University?
- Oteng.12: It pertains to anyone who's taken the benefit, as I turned down fellowships for it.
- **Dean Stromberger**: I'll share my experience: I received an email and was told this was happening. I have provided feedback. The change was originally for a term employee and you wouldn't receive any benefits. It has received pushback and HR responded by taking some things out and kept the payback. It's to reduce the escalating cost of benefits. Again, they have received a lot of pushback and postdocs did come to mind first.
- Durso.19: Send me an e-mail and we can advocate for this pushback on the CGS side.
- **Connor.280**: Just a clarifying question: does that count against postdocs who leave of their own volitation or not?
- **Dean Stromberger**: No.
- 9.1.3) Tech survey not being distributed
  - **Tojelker.4**: The College of Arts and Sciences tech staff for the Department of Geography sent out a survey to us this morning which asked for feedback on Teams versus Zoom. It appears that the University is doing some research to figure out people's usage of the 2 different softwares for video conferencing and classes. I filled out the survey and I'm gonna make sure all that all my constituents in my department fill it out. I believe it's for the wider university, so I would encourage everyone to fill it out.
  - **Durso.19**: I'll send it in the Delegate Digest and CGS newsletter. I'll figure out which department it came from and get permission for us to send it out.

- **Elton.21**: This affects everyone who does research with the IRB. Buckeye IRB will go away in January. There was no announcement made about that, it was just a small notification at the top of the screen saying that they're switching over to another software. What type of differences will there be when submitting to the IRB and how do we handle this shift? This is especially important for dissertations and things that will need to be submitted way ahead of time.
- **Durso.19**: Academic Affairs should put in about software updates without informing, send me an e-mail and we can follow-up.

9.1.5) Summer funding for international students on fellowships

- **Arshad.32**: One of my constituents reached out to me and she was on an external fellowship for the fall and spring semesters, but not the summer. She was an international student and was first advised to find a job at OUAB for summer funding. She wasn't able to and was able to finally find an external fellowship but jobs should be provided for international students if the fellowship doesn't provide summer funding.
- **Dean Stromberger**: I know in general, it's very difficult for a student on fellowship because they have a different tax system than a GRA stipend. Someone on a fellowship is not treated as an employee, but if you're an RA or student hourly you're treated as an employee. A person can't be both so they can't be a fellow and employee at both times. University has said if you're on a fellowship, you can't have a university job. Payroll can't do both, I don't know about how taxes are impacted by international student status.
- Durso.19: Bring it up to OIA!
- 9.1.6) Graduate student fee fluctuations
  - Ledger.21: Transparency for graduate student fees, wondering where these things come from and are going to, how much money is being docked from their paycheck month-to-month, updates from earlier this year?
  - **Durso.19**: I've been contacting the same person in HR every two weeks. Each time, he has been working on it and trying to get answers. Each semester this fee fluctuates because of the length of the semester. They argue you should be paying the same amount each semester. I've been working with Dean of Students and he's very interested in ways to waive certain aspects of the fees. On the other hand, that's very hard to do because some students need these things and some don't and without the extra funding, they can't fill people's desires. Homecoming is very stressful to get answers in admin, so still working on it.
- 9.1.7) Student access to FABE library
  - **Sylvestor.1**: No community study space in Food Agricultural Biological Engineering (FABE) building besides the entrance lobby. Grad students want card access to the FABE library in the Agricultural Administration building. Who should we contact about this?
  - **Durso.19**: Building coordinator should be asked first and why that access hasn't already been given to students. Reach out to me via e-mail about this! I know recently, there was a huge update for student study spaces, maybe we can improve this area as well in this huge update.

9.1.8) Discarding campus leaves

- *McKenzie.517*: Where do all the leaves go when campus cleans them up? Are they composting them or just discarding them?
- **Durso.19**: That is an excellent question for Facilities and Ops. Brittney, me and you can work on that together and try to figure that one out.
- 9.1.9) Follow-up on issues 9.1.7 and 9.1.4
  - Miles.375: Two things: for access to CFAES, I would reach out to Kayla Arnold. She's kind of like
    the graduate program director for the college. And CFAES actually has grad student study spaces
    in the Admin building. So, you might be able to get access to that after hours, because it's open for
    graduate students specifically. For IRB: The University Research committee did meet today and it
    sounds like they're going to be migrating all the IRB tools and data. They've been doing a lot of
    rigorous testing for the new system to make sure there's no issues. There might be some
    difficulties with old software, but it seems pretty efficient from a software standpoint.

9.1.10) OSU e-mail after graduation follow-up from last delegate meeting

• *Karunakaran.10*: Following up on Buckeyemail being removed after 2 years of graduation from the last general delegate meeting



- **Durso.19**: Took this to President Carter and Dean of Students. Somebody looked at all the ways to cut costs. Carter was surprised about the lack of storage (5 GB). Dean of Students and I are working on it and hoping he has follow-up for it
- **Dean Stromberger**: This has been an issue. We're concerned about the Graduate School's abilities to contact students if their e-mails change. They're not moving forward with much else because they're trying to address all the issues this would cause.
- **Durso.19**: Faculty Council which is a large body of people is upset about this as well. They back us up on that.
- **Karunakaran.10**: Buckeyemail carries important conversations about research. I really think for grad students we should have Buckeyemail forever to keep those important contacts and conversations.
- **Dean Stromberger**: A lot of wealthy alumni are upset about losing their OSU e-mails, the president has heard this from a lot of people.
- GuzmanCamacho.1: Is this an issue for ODTI?
- **Durso.19**: ODTI has interim officer right now. Trust that if so many people are looking at this issue that President Carter is aware of it, he supersedes ODTI. Dean Stromberger says it's on pause so I will continue to provide updates from our monthly meetings.
- **GuzmanCamacho.1**: I'm on the sub-committee on Support Office. ODTI has different funding sources. We're having a next meeting and I'm happy to take it to them as well

9.1.11) Technology loans for international students

- **Arshad.32**: International students can't get tech loan and I remember the last update was that these students need to contact OIA. Does anyone know what OIA does once a student reaches out with a need like this?
- **Durso.19**: Tech loans are highly diminishing and FAFSA determines student's needs. OIA does the exact same thing for international students. There's quite a few ways we're exploring to remedy this. 15,000 devices needed to keep up with all the maintenance for devices people have turned in over the last five years. They used to have a big pool of funding but the University took that money from them. Those who do not need devices are being asked to return it so that they can give it to students who really need it. They're hoping this will help offset the cost of new devices and fix this issue.
- **Parajuli.17**: One of my friends tried to talk to OIA for a technology loan. Is it only available for students on scholarship?
- **Durso.19**: Must be a certain level of financial need, not scholarship.
- **Parajuli.17**: That applies to international students?
- **Durso.19**: Yes
- **Parajuli.17**: They told one of my friends she wasn't eligible.
- **Durso.19**: They are trying to find ways of fixing the program. As grad students, there are many ways we should be advocating for not using the technology loan, so that undergraduate students can also have them. If we can find ways to really rely on that institutional tech policy, that would not allow us to do University business on our personal computers, your friend would then be able to get an iPad for research. We're looking into it.

9.1.12) Library system update

- GuzmanCamacho.1: Library system will be updated in July and there will be a new system as well
  as catalogs, etc. If anyone is interested on how this change is going to effect things, let me know
  and I can connect you to the people in charge of the change.
- *Elton.21*: Why? What's wrong with the current system?
- **GuzmanCamacho.1**: The update is to make the system more efficient. There's delays and efficiently issues with information delivery as compared to other Universities. I know they were worried about how people would react to this information, so let me know if you want to get in touch with people.
- **Carrera.55**: On the report there is a section for graduate caucus, and it lists every single Senator and the Senate committees that they're on. If you have any feedback like this that we just talked about for an individual committee, please email that senator or committee chairs in CGS. Truly, I hope you use this break to rest, friends, as we continue to live in unprecedented times. Though I acknowledge that this resource is clearly insufficient, I wanted to share the "Coping with Current Events" page, hosted by Office of Student Life's Counseling and Consultation Services once more. Among other resources, on that page is a link to attend/register for a hybrid workshop every Thursday at 4:00 via Zoom: "Thriving in a Complex World: Coping with Current Events Workshop." I strongly encourage you to attend this session and to direct this resource to all within your departments. Please remember that CGS is always here to support you and all graduate students, so do not hesitate to reach out if you ever need anything, even if it's just a friendly ear.

Over the Past Month:

- **Exec:** We voted in Andy Vance.128 as CGS Parliamentarian and Zaira Girala Munoz (GiralaMunoz.1) as Chief of Staff! We have a completely full exec team for the first time in two years!
- **Grad Council:** Dean Stromberger and her team are working hard! Currently, they are in the process of making a <u>mentoring toolkit</u> that will set best practices for advisors and advisees across the university. The College of Engineering is working on something similar to this currently. Additionally, they are working on setting <u>best practices for admissions processes</u> based on those approved by the Council of Graduate Schools.
- We continue to work on Graduate Student Leave Policies this year, amongst other things. If you have any ideas/concerns about leave, let me know!
- Steering/Senate: Senate convened and hosted the Chase Center leaders. While CGS remains concerned that the center lacks any oversight or plans to include graduate and international students, the majority of Senate is accepting the Chase Center on campus. We vote on the Chase Center's acceptance into OSU in January. The center is government sanctioned, so regardless of the vote, the center will open in 2025.

## Working On:

- **CGS Newsletters:** Just waiting on Legal to approve contracts. The Grad School is prepped to send emails for Hayes and Grad Student Appreciation Week.
- CAMPUS Act TaskForce: The Campus Accountability and Moderization to Protect University Students Act requires public institutions in Ohio to create a task force on combating antisemitism, Islamophobia, and anti-Christian discrimination and hatred, harassment, bullying or violence towards others on the basis of religious identity. If you have any thoughts on any of the above, please contact me! I welcome your wisdom!

Updates from Past Delegate Issues and Concerns:

- IRB Transition: Heads up! A MAJOR transition for OSU's IRB system will take place in January 2025. OSU is transitioning from <u>Buck-IRB to Huron systems</u>. It is expected that during the transition from <u>mid-January through mid-March</u> there will be a period of time where you will not be able to submit a new IRB protocol or revise an existing protocol. The Office of Research will be migrating all existing studies from BuckIRB to Huron (you will not need to do this yourself). However, this will create a temporary disruption in the IRB submission process. Thus, the Office of Research is recommending all researchers to get any new protocols, annual reviews, or revisions to existing protocols submitted by the first week in January so that they can be reviewed and migrated. If you have anything planned that will need IRB approval before the end of March, you should submit through BuckIRB by the first week of January if not before. If you have legacy studies that were created prior to 2014, you may also receive a separate email from the Office of Research will be releasing more information soon.
- SHIP Dependents: A few meetings ago it was brought to CGS's attention that though children are eligible for SHIP coverage, it does not say so on the SHIP website. I have finally found where it states who is eligible and have included it <u>here</u> and on the CGS resource page.
- **RPAC Shortened Hours over the Summer**: I've been informed that the RPAC closes an hour early in the summer due to difficulty staffing, especially in the summer months, as well as low usage.

<u>Please</u> continue to share information on the forum with your constituents, colleagues, friends, enemies, etc. TLDR; if they're a graduate student, tell them to consider applying for Hayes! It's a

# Fiscal Committee – Gabriel Guzman Camacho (guzmancamacho.1)

The meeting happened on October 22. Update of HRSD. Update of the internal subcommittees. Some of them haven't met yet. Discussion about laptops and tech borrowed from university to grad students. Also, discussion of the grad minimum stipend (18% in the next four years).

#### Graduate Comp & Benefits – Brian Rocha.51 (rocha.51)

Next meeting is 11/21: We are voting on new bylaws and operating procedures and also voting on 2 - 3 main issues to tackle for the year. Once that is finalized, we will update everyone.

## Diversity Committee – Deb Pathak.89 (pathak.89)

Iterating on DEIJ survey questions and branding to be sent to Deans/Dept chairs annually. Discussed areas of improvement identified from last year's DEIJ survey, but not enough information available on which Department, College, etc. the complaints are from, so it is difficult to do targeted advocacy or know who to reach out to.

Looking for guest speakers to invite to monthly meetings, reserve 30 minutes each meeting to hear updates on DEI work and challenges in different colleges. Will elect new chair at next meeting.

#### Council on Student Affairs – Krutant Mehta (mehta.337)

The Council on Student Affairs heard a presentation from the Chase Center for Civics, Culture, and Society. A slate of university organizations departments have been scheduled to present to CSA starting off with OSUPD's new Police Chief in early 2025. Work on the 2025 Student Activity Fee Redistribution has continued.

#### Intellectual & Property, Patents, and Copyright Committee– Brian Rocha (rocha.51) No updates.

#### Council of Academic Affairs – Andrew Miles (miles.375)

CAA is preparing to evaluate the Chase Center proposal. The proposal is now within the subcommittee. Graduate students have voiced their concerns at the university Senate; however, the proposal spoken about now has a large addendum. By the December CGS meeting, the committee will have evaluated the proposal in CAA and a verbal update can be provided. Andrew is working to ensure that our concerns are heard and hopefully addressed. Also the university is taking a survey of the use of experiential learning; a report may be provided to CAA and CGS upon request. We have had revisions to the MGIST, HIMS, and GISD. We also added a new grad certificate in nonprofit management with revisions to that grad minor. Revisions also took place to the Master of Dietetics and Nutrition, Biomedical Clinical and Translational Science Inter. Specialization, and the Master of Respiratory Therapy program.



Council of Academic Freedom & Responsibility – Jorge E. Clavo Abbass (clavoabbass.1) Has not met, planning to meet in December.

#### Rules Committee – Jorge E. Clavo Abbass (clavoabbass.1)

Met 1 and 8 November. No items for dissemination.

#### Library Committee – Gabriel Guzman Camacho (guzmancamacho.1)

The meeting happened on October 15. LSP migration of service platform and what that is going to look like.

#### University Research Committee – Tony Annerino (annerino.2) / Andrew Miles (miles.375)

URC met on November 1st, and mostly discussed topics not relevant to the graduate student experience like restructuring of promotion paths for research professors who do not teach or serve as graduate student advisors. There was a briefing by the URC member who was selected to sit on a sort of joint review committee for the Chase center that included no substance or original commentary, just the ubiquitous "this is bad" we have all heard phrased so many different ways over the last few months. The most graduate-student-relevant topic of substantive discussion was about ongoing work to make monitoring grant funding in Workday more user friendly, which now includes looking into the access given to graduate students who brought in grant funding since graduate students especially seem to have trouble monitoring this even more than most faculty.

# Committee on Academic Technology – Tony Annerino (annerino.2)

CAT met November 4<sup>th</sup> and received a presentation from interim CIO Ginger Breon. Faculty already brought up the Overleaf issue with her office some time ago, so they had already been working on access solutions for a while; it seems to be a high priority of theirs given how fast they are working toward a solution. Institutional spending on Overleaf was previously about \$47,000, and an institutional license would run about \$147,000, but there is a cheaper potential solution for on-site hosting that is currently being piloted and seems to be showing promise. The rest of the meeting was dedicated to discussing the charges of the 2 subcommittees, one dedicated to Ohio State Online and the other to on campus learning and research needs, and I requested to sit on the latter of these subcommittees since it seems more relevant to the wider graduate student experience. The next CAT meeting is scheduled for December 2<sup>nd</sup>.

#### Council on Enrollment and Student Progress – Thomas Elton (elton.21) No update

#### Government Affairs – Bryan Perez Soto (perezsoto.2)

The committee met and discussed how the office of Government Affairs would assist in providing information and guidance. The meeting also used the time to provide suggestions on how the committee should proceed. Further, discussions are being brought up to select a chair.

## Council on the Physical Environment – Brittany Multer Hopkins (multerhopkins.1)

The committee has only met once back in early October. Currently the chair is working to finalize our action items for the year and split the committee into sub-committees.

# Hello!

It's getting cold out there, so our December sustainability tip is to prepare for the cold!

- Clean or replace the filter in your HVAC unit so that your heater runs smoothly and uses less energy this winter.
- Set your thermostat to around 68°F to 70°F while you're awake (and you can set it lower while you're sleeping or away from home to save energy).
- If you drive, make sure to **check your tire pressure.** Cold weather can cause low tire pressure and lower fuel economy. There are four complimentary air pumps on campus in Columbus. Gas stations often have free air pumps as well.
