- 8.1. Resolution Regarding OTDI Policy on Licensing, Technology Accessibility, & Software Updates 8.1.1) Rationale for the Resolution
  - Daniel.508: University has made decisions about technology without consulting with grad students or CGS. This resolution refers specifically to Adobe and OneDrive and recent changes made by the University to this software. The resolution asks specifically ODTI to ask CGS and grad students to get input before making changes to this software and communicating those changes effectively to CGS/grad students.

#### 8.2.1) Q+A:

- **Q: Mace.103**: This doesn't take position on specifics on Adobe Access, are we waiting on data and why did you not include it here?
- Daniel.508: What specifics are you referring to?
- Mace.103: There was a survey on Adobe Access and how the new mode is not efficient and
  this wasn't included in the Resolution. Are you considering writing something on that with more
  data?
- Daniel.508: If you have that survey available, we'd be interested in putting that into the Resolution. Priority was given to Adobe and OneDrive and communicating decisions on that.
- Q: Karaunakan.10: Are we trying to get the University to keep the existing storage we already have?
- Daniel.508: Not asking University to turn around on the decision they made about the storage, but instead just asking for students' input before making big decisions like this. Give me one second, we thought about adding a line to the Resolution about this but didn't. If that was brought up during the discussion, we could discuss more.
- Karanuakan.10: What would have been the line?
- Daniel.508: The line would have talked about making a difference between undergraduate and graduate students, since students are just given storage as a whole and there's no difference between the two in terms of storage capacity. Because grad students are at a 0.5 FTE, creating a discrepancy between how it impacts graduate students and undergraduate students. We did not come to a conclusion on what that line would like look though, so we decided not to include it. I feel we could write a future resolution about this, depending on how this resolution goes.
- **Karanuakan.10:** What exactly is the memory limit that we intend to bring up? Are we trying to give them a minimum number that's needed for a grad student?



- Daniel.508: We did not determine a number.
- **Karanuakan.10:** Is there a way we could determine different amounts of storage for different graduate students?
- Connor.280: Point of privilege: this is great. But perhaps we should save some of this. I just wanna make sure that if other people have questions that we get to those as well, and make sure that we're freeing up for multiple people to have conversations.
- Q: Arshad.32: Did we know the motivation for the software changes?
- Daniel.508: We did not talk to anyone about these changes, did you Sabrina?
- Connor.280: I don't think we've met explicitly to talk about this. From our understanding, they're cost-cutting measures for the University.
- Durso.19: It has been brought up in University Senate steering. Largely, it seems faculty, staff
  and students are upset about the lack of communication, which is why we've kept it to just the
  communication issue. Arguing against cost-cutting measures is hard so communication was
  the priority.
- Q: Lebeck.31: For clarification, was no one consulted about this? Was it just random?
- Daniel.508: Regarding the decisions made?
- Lebeck.31: Yes
- **Daniel.508**: Checked my e-mail, as a Student Life employee, I was contacted via e-mail about Adobe. Some departments may have communicated this to their students, but grad students at large and CGS was not contacted which is the premise of this resolution.
- Durso.19: There was no centralized form of communication between faculty, students and staff for these changes.
- Q: Arshad.32: Are we demanding just the communication or a discussion before these changes are implemented too?
- Daniel.508: It's asking for them to have a discussion with us. We found a news article about
  the changes, but it was never communicated to us directly. Grad students shouldn't have to go
  out and find this information.
- Booker.200: Motion to extend our time by 2 min for a question?
- Seconded by McDowell.310
- Motion passes
- **Q: Booker.200**: What actionable items do you want the University to do in this Resolution? Do you want to consult CGS in a particular fashion? What constitutes a timely manner? The language is vague, and specifics would be helpful. What changes would this apply to in the future such as Adobe?
- Daniel.508: Future changes: Let's say OSU wants to move from Outlook to Gmail, they need
  to have a discussion with us, specifically CGS, and communicate it. Timely manner: I don't
  have any specifics since the time varies for these decisions already, but again this primarily
  advocating for the University to consult with CGS before making these changes.

#### 8.3.1) Discussion:

#### CGS Representatives in other organizations as a way to communicate important issues

- Fritz.288: Comment for discussion: Do we have a CGS representative in ODTI? This could solve the problem of no communication.
- Annerino.2: As the CGS senator for University Senate Academic technology committee, I feel this is the natural way to give communication. It would be a natural way to give communication, but we were never informed which is why there's a push from everyone for more communication.
- **Lebeck.31**: Could we add more specific language about how we would communicate with us? Like telling them to go through this specific Senate committee that we have a CGS rep on.
- Move to add this to the Resolution by Lebeck.31



- Seconded by Mace.103
- **Lebeck.31**: Just want to add how specifically we would be communicated through. Given that this would be through the Senate committee, there will also be more faculty, students and staff representation in order to keep more informed. Since everyone seems to be against this, the Senate would be the best way to have this communicated.
- **Multerhopkins.1**: I think we should also add on that they include the CGS president at the time, sometimes we don't have a senator there and just in case the senator is absent from that session of the day, we keep them informed.
- **Durso.19**: Any other suggestions?
- Miles.375: Probably adding the University Research Committee would be a wise idea, because we
  have CGS members on there, and they have a lot of conversations with the Dean of Research I
  think and the University Libraries.
- **Daniel.508**: Does anyone have any opposition to the suggestion at hand before I make a motion to add it to the Resolution?
- Mace.103: Do we have grad reps on any ODTI bodies?
- Connor.280: Historically ODTI used to have an advisory technological committee, but they don't
  have the committee anymore. At least to my knowledge, there's not a standing committee advising
  ODTI.
- Mace.103: If they don't have reps, then we shouldn't include those avenues of communication to be more concrete.
- Booker.200: Can we add concrete language to urge the University to contact one of these
  avenues of communication? Language is wishy-washy and they won't contact unless it's more
  specific.
- Motion to extend by 3 min by Mace.103
- Seconded by Booker.200
- Motion passes

Amendment added: BE IT FURTHER RESOLVED that CGS believes that units making policy changes must contact at least one of the following bodies with graduate representation/graduate representatives: the University Senate and it's appropriate committees such as the Committee on Academic Technology (CAT), the University Research Committee (URC), and the CGS President and Academic Affairs Committee.

- Daniel.508: I move we include this statement in Line 86 of the current resolution.
- Seconded by McDowell.310
- · Motion adopted

#### Adding a certain amount of storage requirement

- **Karanukan.10**: Can we put a line about a survey asking about the amount of storage that is favorable for all graduate students and to justify this change?
- Teafatiller.1: Do you mean they need to provide us justification for the storage change?
- Karanukan.10: Yes, why such a significant reduction?
- Motion to extend by 5 min by McDowell.310
- Seconded by Multerhopkins.1
- Motion passes
- **Connor.280**: This is not the time to offer multi-part motions. There needs to be a clear and specific motion on the floor. What I'm hearing is you want us to add a line asking the University to provide rationale for why the storage limit for graduate students has been reduced?
- Karaunkan.10: What I'm suggesting is some academic body passing a survey along to all grad students before they make a significant change to the amount of storage. The point of the survey would be just getting an average number for the amount of storage a graduate student needs.
- Connor.280: So you're wanting to add that there needs to be a feedback survey for any storage limit change. Do I hear a second for the motion?
- No second, motion will not be entertained

#### Clarifying language on University consulting grad students

• **Allen.2234**: Should we make the line "Must consider graduate students" more specific? The University could just say we were considered, but not actually do anything concrete with that. Did other people get that impression?

- **Connor.280**: So there's a motion on the floor to clarify this language, what does it mean to be considered? Do I hear a second?
- Seconded by Booker.200
- Motion passes
- Connor.280: Where do you want the specific changes?
- Allen.2234: Looking at the second to last section where it says 'must consider graduate students
  holistically across our roles'. Point of clarification: is this meant to say that by considering us you're
  directly contacting us?
- Mace.103: May I suggest 'consider and consult' graduate students, what do you think abou that?
- Allen.2234: I liked 'directly consult'.
- **Lebeck.31**: I think the major point of that passage was that when the University thinks of grad students, they need to think of us as employees and researchers. That's what I took away from the passage. If not everyone else is getting that, then we can discuss more.
- Motion to extend by 4 min by Daniel.508
- Seconded by McDowell.310
- Motion passes
- Daniel.508: Clarification, it was to consider graduate students in multiple roles. This line specifically
  refers to graduate students who are a lot more just students. We're teachers, researchers, we have
  a lot of other roles. Whereas with the OneDrive policy, we're just lumped into students with the
  undergraduates even though we have multiple roles.
- Miles.375: Is it confusing that we just said directly consulting with us when we asked to indirectly
  consult with us through these committees. This statement could be at odds with the previous
  amendment.
- Lebeck.31: I was confused by the language but that makes sense.
- Allen.2234: That interpretation makes a lot more sense, I was confused by the language. Maybe
  we can say 'recognize' instead of 'consider' since that might be more direct.

Amendment added: BE IT FURTHER RESOLVED that CGS continues to reaffirm that the Ohio State University (and all its constituent units) must consider and acknowledge graduate students holiostically across our multiple roles as students and employees (teachers, researchers and more) at OSU in order to properly consider and address graduate students' complex and interlinked needs with regard to education, research, professional development and more.

- Motion to adopt by Lebeck.31
- Seconded by Daniel.508
- · Motion adopted
- Arshad.32: For future, I think this was a good discussion and for other discussions that we had in
  this session, I do think we should talk about them. We were kind of stuck between 2 different things
  for the amendments suggested, but I think even with this resolution, they will think more about
  future changes.

#### 9.1. Delegate Issues and Concerns

- 9.1.1) Communication between Student Life and Housing/Family Affairs
- Arshad.32: Continuing the discussion earlier, we need similar resolutions for other areas of
  changes needed. They changed bus routes last year and due to cost-cutting had to take down
  specific routes. This affects people in choosing housing that they can get transportation to and
  from. We were never considered nor communicated in those changes, what can we do in those

#### Intro & Misc.

While Sabrina and I continue to be "on the clock" throughout the break, not much changes as most of the university goes formant for a few weeks. I've included pertinent updates below as necessary for anything to draw attention to.

#### **Internal Operations Updates**

I have updated the website with the timelines and deadlines for all upcoming elections this spring (Officer, Senator, & Delegate). I'll be working with Andy Vance (Parliamentarian) as he supports me in chairing this final round of elections for my role as VP and election chair. I'll have timeline updates/reminders in all the reports (verbal and written) from now through April so everyone knows what to expect and when to expect it. It is bittersweet to say the least setting up this last round, but I'm excited to share some updates in a meeting or two as we propose some bylaw changes that will tweak and further refine how we run our elections.

## Hayes Advanced Research Forum 38 - #49DaysTilHayes

Thanks to the massive push from CGSers sharing the CFP, the Graduate School pushing it out and emphasizing the opportunity to graduate faculty, and college deans pushing the CFP to students, we rocketed forward in applications over the three week extension, and had a 10-year high in applications! Committee members Deanna Holroyd, Joey Oteng, Casey Ortbahn, Sabrina Durso, and volunteer reviewer Blue Lerner deserve extra kudos for turning around abstract formatting and anonymity reviews out over 6 days during finals period so we could have a full 4 weeks for judges to do abstract scoring.

At this point (when I wrote the report on 1/6), abstracts are 30% scored, which is healthy given that the scoring is January 17th. I'll send a few more reminders to judges in the next two weeks to be sure scoring is completed on time. After the 17th, we'll hopefully have decisions rolling out right on time the following week. At that time, I'll be renewing the search for day-of judges, as we have a few academic areas we're short for.

Formal volunteering info and signups will be going out sometime next week, but we've had 40+ people already reach out in interest, which is a decent number. We still need more and will continue to recruit to be sure we have plenty, as there are usually late volunteering dropouts for various reasons. There's no limit on how many people can get a CV line for this volunteering, so I'd rather share the wealth around to ensure a smooth day's event.

## **Updates on My Committee Work**

Throughout the fall semester I served on a committee evaluating the university's needs and interests in name pronunciation software, as our previous contract was ending, and OSU wanted stakeholders to see what would be "best" moving forward. I tested software, attended demos, discussed with other committee members, and heard reports on cost, contracts, technology, and accessibility. At this time, the committee has recommended that we renew our contract with Namecoach. This is due to a number of factors including cost (of the tool itself in



addition to considerations of maintaining the current tool versus training hundreds of faculty and staff on a new one), accessibility, and current offerings (a concern expressed by a number of us included compatibility with Carmen and other relevant platforms for the myriad of roles using the software).

I was pleasantly surprised and delighted that we all agreed unanimously, and additionally that so much of the conversation surrounded not only the software choice specifically, but reinforcing the importance of name pronunciation software to increase inclusion, provide better networking and community-building opportunities, emphasize the value of diversity at OSU, and professional development across a number of fields where cultural-competency is a must for practitioners and researchers alike. We additionally included in our report the request that OSU increase its resources and training on the use of Namecoach, so that more folks know it exists, where to find it, and how to use it, as lack of training and knowledge of the software was a huge barrier cited by me as the Grad rep as well as IPC's rep and other members of the committee.

I'd be happy to give even more details to anyone curious! Just reach out to me.

I hope everyone enjoyed some of the beautiful snow earlier this week, and remained safe and warm throughout the first week of classes. Looking forward to seeing and chatting with folks on Friday.



Happy New Year everyone! We have some promising updates regarding housing orientation for incoming students.

The HAFA committee met with OIA and OCCSE in December to discuss improving housing orientation for incoming students, particularly international students. Last year's orientation included a brief off-campus housing session (see <a href="Pre Arrival 1 Presentation 1.pptx">Pre Arrival 1 Presentation 1.pptx</a>), which primarily focused on OCCSE resources. However, we all agreed that there is a need for a more comprehensive guide to address the unique challenges international students often face in finding suitable housing, figure out family affairs, understanding lease agreements, and navigating local regulations.

During the meeting, we brainstormed potential topics for the orientation, but nothing was fianlized. OIA wants to meet again in January to finalize the content and logistics. This orientation will also involve Student Legal Services (SLS) to inform students about important legal points regarding housing and renting policies. To ensure the orientation is truly helpful, they also want graduate and international student representatives to participate and assist with queries.

We will be collaborating with ISA to review the orientation content and potentially organize a focus group to gather further input and ensure we are addressing the most critical topics. Next steps include:

- Collaborate with ISA to review content and potentially organize a focus group.
- Meeting with OIA, ISA, OCCSE, and SLS to finalize orientation content and logistics
- Gather CGS members input either through a survey or a focus-group.
