8.1 Grad Caucus Further Updates & Discussion

8.1.1) Lyft program updates:

Guzmancamacho.1: I currently am in 2 committees in the Senate, the Fiscal Committee and the Support Office Committee. Support Office Committee receives applications for funding for certain units of the university and one of the last applications was for the Lyft Program. The program basically is a discount on rides given to university students from a certain time to certain time in certain areas of Columbus near the University. Last year, the program cost 1.5 million dollars and this year they're asking for 3 million dollars. The University is signing contacts this year for increase in some budgets, but it's unclear if it will be honored, saying that if they have the money they will give it. The Lyft program isn't a program itself, but rather part of a security for students program. There's a group of people that get together and decide what safety and security means for students on campus. One of the big questions that came up was why are we spending 1.5 million dollars on this type of safeness and are there other areas we could be spending that money in. They discussed moving the map of the Lyft program because about 30 to 40 percent of the map doesn't have anyone using the program, but we're paying for that area. I suggested changing the area, but that would mean there would be more users and thus we would need more money. What are your thoughts regarding safety and security on campus and is this program useful?

- **Tjoelker.4**: Was there any data that was presented on students using this service or how much money was being spent to cover these rides?
- **Guzmancamacho.1**: There was data presented but it was presented on users and not why we're using the program. How many students were using the program and how many rides were present in each area itself.



- *Tjoelker.4*: Basically, we don't know how many rides are taken?
- Guzmancamacho.1: We know how many rides were taken with the program.

8.1.2) Overleaf software and ERIK office update:

- **Annerino.2**: The University's lead contract guy says he anticipates a contract being signed by the end of the month for Overleaf. About the Buck-IRB to Huron-IRB system transition: ERIK office is forecasting it to go live on March 20<sup>th</sup>.
- 8.1.3) Lyft program updates [cont.]:
  - **Durso.19:** Does anyone else have any ways to update Gabriel on the Lyft share program?
  - **Unnava.4**: Do you have data on the median number of rides that each user is taking?
  - **Guzmancamacho.1**: No, I can ask them if they have that data. They were more focused on how many students used the program from 7-7. So there is a need and we've been asked to make a change to the program but what change we don't know yet
  - **Unnava.4**: I use it a lot because I'm on the edge of the zone. Do a lot of people use it sparingly or are there a group of users who use it all the time?
  - **Guzmancamacho.1**: There's a huge portion of the northwest where there's no users and there's areas in the South Campus where there's a lot of users. They were talking about moving the borders but if they do that to areas with more users, then there will be more usage and would therefore need more money. The Lyft program is a way to make campus more safe, but the conversation has been focused on what safety means.
  - Elton.21: Motion to extend by 5 minutes
  - Seconded by Unnava.4
  - **Elton.21**: Regards to safety, have they ever brought up weather concerns? Because I used it just this morning and I often use it after 7 when the weather is coldest. Maybe they could put inclement weather into the algorithm so that students can come and go to campus safely.
  - **Guzmancamacho.1**: The conversation of safety has been focused on crime. They're trying to understand safety and how it affects us. The conversation has been driven by places with more crime than other safety concerns such as weather. Let's keep the conversation going about what safety means.
  - **Durso.19**: By a show of hands, how many people would or have used this service in this room as a graduate student?
  - *Guzmancamacho.1:* So it's about 50/50 and we need to have this conversation
  - **Soni.117**: So if the question is, how efficiently can we use the 1.5 million in terms of improving safety, then one way is a shared cab right? If you want to use that money to improve the services, you could have multiple locations to pick people up near campus. That would be a better way to use it in terms of like ensuring safety. There could be two options: one is you have the luxury to take one cab for yourself and the other is you go home while you're sharing with a couple of students. So, in terms of safety, that might be one way to bring costs down.

- 9.1. Delegate Issues and Concerns
  - 9.1.1) Pay disparities:
  - **Ramprakash.4**: Regarding one of my constituents, last year we got a raise for the graduate student stipend, but he didn't get a raise despite being a student of the College of Engineering. There is a disparity in the minimum stipend between the departments in Engineering.
  - **Durso.19**: There are pay inequities throughout the University across different colleges. The raise only affected those on the minimum stipend. Please have them email me and we can discuss that more. Across the colleges, unless you want to talk to the Dean, it would be a very complex issue to talk about.
  - **Arshad.32**: In addition, if you're on a grant on NIHNSF, advisors don't have to increase their stipends if it comes from different sources of funding. Colleges can set their minimums.
  - **Durso.19**: If your department can fund you if the NIH goes away, then it's not an issue.
  - **Annerino.2**: I have a bit more context that we can speak about over the e-mail. There is precedence that students are paid by the advisor's primary department. A Physics student who had a primary advisor in MSE and he did not receive his raise after his candidacy. So maybe this is what happened.
  - Karuppuchamy.1: How many departments give a raise after their candidacy exams?
  - **Durso.19**: Let me ask the the Committee of Graduate Student Benefits and we can get an exact number.
  - Annerino.2: Tangential to that, what happened to this situation with the physics student, he
    got a new primary advisor in physics. We, are not in any way, permanently bound to OSU. If
    things are really bad, every single one of us can find a higher-paying job than a GA. Don't
    forget this option.

9.1.2) Paid leave for International Students:

- **Ramprakash.4:** Regarding follow-up to the issue about international students paid vacation. GRA is 10 days and this is not feasible for international students.
- **Durso.19:** I continue to work with the graduate school about the leave policy. Faculty continue to be the loudest jerks in the room. I've advocated for 5 months. I've talked to Dean Stromberger, I'm advocating as hard as I can. I do believe the leave policy will be updated in the upcoming academic year. Ridiculous for international students but also for pregnant graduate students, sick graduate students. I promise there will be an update on that issue.
- *Ramrpakash.4*: Is there a way we can instead ask for a working from home policy?



- **Durso.19**: Per the state of Ohio, if you work for Ohio State, the majority of work during the semester has to be done in the state of Ohio. It's something else I'm advocating for in these leave policies.
- **Arshad.32**: In terms of working outside of the US, I think there would be an issue for tax purposes.
- **Durso.19**: It's handled privately behind closed doors usually, but you're right Muraza there are road blocks at the state and federal level.

### **Officer Reports**

Colleagues,

I have stared blankly at this page for days not knowing how to address you of all current policy decisions occurring at The Ohio State and the state of Ohio. I am always available to discuss and share any of your concerns pertaining to how the ever-changing political climate inside and outside of OSU affects our lives as Buckeyes. I promise I have worked diligently this month alongside many CGSers to support the concerns of our constituents and I will continue to hold OSU administrators accountable for their actions. This month has been hard and my report reflects that. However, I have been flooded with messages of gratitude for the work CGS has done this year and especially this month—and these messages come from grads, undergrads, prof students, faculty, and staff. We are making a difference, friends. Now is the time to be as active as you can while also finding support through community. Most importantly, please prioritize taking care of yourself. CGS is here for you, and we will not be going anywhere.

### Over the Past Month:

- University Senate and Anti-DEI initiatives: As I hope many of you have heard, <u>President Carter announced The University will be proactively working toward</u> <u>implementing all anti-DEI legislation</u> regarding SB1, the Department of Education's Dear Colleague Letter, and more. In this remarks, Carter noted The University's initial steps are to "sunset" the Office of Diversity and Inclusion and discontinue all programming and services offered by Student Life's Center for Belonging and Social Change on February 28, 2025, and that the Office of Institutional Equity will be renamed the Office of Civil Rights Compliance. Attached to the delegate packet is the statement I gave regarding these actions. I intend to reword this language to use in my speech at the Statehouse. If you have thoughts, please let me know.
- Changing the name of the Center for Belonging and Social Change: It is important to note that CGS is being actively consulted regarding changing the name of this facility. We have advocated that other student organizations have a say in the rebranding/shaping of this space.
- **Graduate School:** The Bursar's Office is attempting to end the Graduate Student Payroll Deduction service. This is unacceptable, as if this service is terminated, students would need to pay these fees monthly, and they may even have to enroll in a payment plan that costs \$30 a semester. I am doing my best alongside GCBC to argue against this move. Additionally, a pay increase may be coming—no official word yet but I have heard the rumors.
- **Board of Trustees:** Katie and I are serving on the Board of Trustee's Search for a new Undergraduate Trustee. We should have one appointed soon. Additionally, we were able



to have dinner with two of the BoT members, where I spoke on the importance of accessibility on campus and online.

- **Preparing for Possible ICE Agents:** Katie and I met with the immigration legal services folks and are trying our best to advocate for a wallet-sized notecard to be made that would offer a speech for GAs to use if confronted by an ICE agent. More info to come.
- **Funding Concerns:** If you have a funding concern, ERIK would like you to reach out to them, as per CGS's special bulletins. Additionally, we are working with Grad School for a Town Hall where grads will be able to voice their funding concerns to Dean Stromberger. More info to come.
- **Exec:** Welcome Lauren Levesque as co-chair to HAFA and Shiddhartha Ramprakash as co-chair to R&DO. We also had our executive retreat where we focused on teambuilding, the realities of failure, and had a behind-the-scenes tour of the Union!

- <u>Resolution on Beyond Compliance</u>: Upon sharing this resolution with all relevant offices, Provost Bellamkonda has convened a working group of many higher administrators to ensure it is acted upon. This month, I met with Director of SLDS Cheryl Lyons to solidify CGS's support of their office. Additionally, the resolution was officially supported by Senate via majority vote. This ensures faculty buy-in and support.

### Hayes39 - #DontCryThatItsOverSmileThatItHappened

TLDR version; it was an emotional but great day! Detailed version; Due to the chaos of the University's sudden announcement of closures, downsizing, restructuring, etc., in anticipatory compliance of SB1 and the Dea Colleague letter, we had a rush of emails and communication Thursday (2/27) evening concerned with whether Hayes would move forward, if some areas would be cancelled, or if we would be pulling individual papers. I shot an email out stating we absolutely move forward with everything as planned, and that Hayes would <u>always</u> be a home for <u>all</u> graduate and postdoc research. We had some late shows and some no shows for both session chairs and judges (norovirus is real, wash your hands). We were able to shuffle things around and keep us running with minimal delay and chaos, and no session cancellations. I have sent follow-up nastygrams tattling on judges who failed us to relevant administrators so that hopefully they're reminded what an unfair burden that puts on grad students.

We made additional updates from feedback received during the 2024 Hayes. They were received incredibly positively. Here are the highlights.....

Food:

- The upgraded breakfast offered better variety for folks, and the greek yogurt and boiled eggs meant more protein to fuel people (additionally much praise for the cinnamon rolls).
- We had all day coffee and tea for better caffeination for all of our participants and guests, and light snacks between sessions and luncheon to help stave off "hanger".
- We had water stations all over for more accessible hydration.

### Sustainability:

- Vegetarian luncheon was well-received, as were the composting bags and the move from plastic ware to "real" plates where possible and compostable options for grab and go disposables.
- We collected 1/3 of our lanyards and badges back from folks who didn't want to keep them, so we can reuse in future years to reduce our carbon/waste footprint, and also decrease spending.

### Day-Of Details:

- Signage and navigation were better this year.
- Eagle Exhibits continues to be some of the best money we spend for their speed and professionalism in setting up and tearing down the poster materials.
- The quiet/decompression room/space, while not used, was well-received as a concept.
- We had 13 talk sessions and 5 poster sessions, with a final total of 204 participants on the day of the actual forum (111 talk presenters, and 93 posters)
- We had 76 judges total show up on the day of the forum itself.
- Again maxed out luncheon attendance.
- We've already received 7 post-Hayes emails and numerous conversations after sessions and awards giving CGS positive and thankful feedback for the quality and planning of the forum in the face of higher education's funding/DEI/political/etc. struggles, and our unyielding support and commitment to graduate and postdoc opportunities in the face of all that.



I'm tweaking the feedback form from last year, and it'll be sent out between the authoring of this report and the CGS meeting Friday 3/7. I'm looking forward to compiling those results to hand them to my successor, in addition to my own extensive Hayes manual, and additional notes and personal feedback on the planning of the forum, some further judging application updates, and notes on things to continue to hopefully keep us financially responsible, while maximizing the experience for participants.

I look forward to extra embarrassing some of the committee, volunteers, and participants at the meeting for their hard work and brilliance in making this Hayes a success. You know who you are. Brace yourselves. I'm proud of us ALL for showing up and showing off our skills and dedication.

As always, folks should never hesitate to reach out to me via email (conner.280) if they need. I'll likely be mostly out of touch over Spring Break (like we all should be) so I can take a deep breath and make up for the writing I didn't do in the final 2-week lead up to Hayes.

### Academic regalia:

Recently, CGS has been getting many questions related to academic regalia. To be transparent about our advocacy and purchasing of regalia for the lending library program, I have included a summary of our work on the academic regalia project since 2023 that I wrote for our annual student activity fee (SAF) funding review:

As part of a carry forward allocations request from CGS to CSA last year, CGS requested \$35,000 to start up a doctoral regalia lending library program. The original intention of this request was to purchase ~30 complete (hood, tam, robe) regalia outfits and offer these outfits to graduating PhD students for commencement in spring 2024. In the fall of 2023, the CGS Academic Affairs committee, led by former CGSer Garrett Tatum, set out to:

1) generate operational documents including a contract and description of the program as well as the mechanism of applying for regalia

- 2) communicate with the University Bookstore and receive a quote for mixed sizes/ of regalia
- 3) determine the logistics of storage and return of regalia at the Ohio Union

Given concerns by the Office of Student Life and the Office of Business and Finance regarding the relatively high cost of the purchase request, concerns with the fiscal stipulations of using SAF funding for the project, and concerns of determining how applicants are chosen for a rental (e.g. financial need vs. a lottery system vs. an essay), progress on project realization was delayed. In spring 2024, rather than purchase regalia, committee work shifted to more of an advocacy role to motivate university administration the need for a regalia lending library program. Members of the Academic Affairs committee, CGS leadership, and other CGS delegates researched and created a report on the state of doctoral regalia purchasing and rental at OSU, schools in the Big 10 conference, and the five largest institutions in Ohio by student enrollment. This report was given to staff in the Office of Student Life as well as the Office of Business and Finance to demonstrate the need for such a program at OSU and the significant financial burden of regalia rental and cost to OSU PhD students compared to peer institutions. During summer 2024, this report was utilized to revive a dialogue with Senior Assistant Dean for Graduate Student Experiences Matt Page and Director of Graduate Services Tim Watson concerning the costs of regalia rental at OSU. Page and Watson are currently in communication with regalia distributor Barnes & Noble and regalia manufacturer Oak Hall to determine the breakdown of price in regalia rentals. Furthermore, this report has been utilized to support the purchase of doctoral regalia, and we submitted documentation for a formal purchase request to the Office of Business and Finance in January 2025. Currently, we are awaiting OSU legal and the head of finance in Student Life to review our request. Thus, since our original request in fall 2023. CGS has:

1) generated documentation outlining the operation of the program,

2) researched and determined OSU charges more for doctoral regalia rentals than any other school in the Big 10 conference or the top five largest institutions in the state of Ohio,

3) formally submitted our request for purchasing regalia, and

4) continued to communicate with administration in the Office of Student Life, Office of Business and Finance, Graduation Services, and the Graduate School regarding execution of the program.



Thank you for your patience with us, understanding our motivation to establish an academic regalia lending library, and for supporting our initiative to defray the cost of attendance at commencement for graduate students.

Given my position as Treasurer and relationship with the Student Life business office through my role, I have been spearheading this initiative since summer 2024. When further updates are requested or a major change/update happens, I will let you know. In the meantime, I would be happy to answer individual questions as they arise, recognizing that this work is still actively happening.

### Council on Student Affairs – Peter Carrera (carrera.55)

The Council on Student Affairs is continuing work on the Student Activity Fee Review (reviewing beneficiary submitted information). A CSA ad hoc small group is working on additional options for the update to the Code of Student Conduct after receiving feedback from Faculty Council & different university senate leaders. These options will be submitted to CSA for review and finalization. We heard a presentation from Ryan Lovell (Health and Wellness) and Dr. Micky Sharma (Counseling and Consultation Services).

### Intellectual & Property, Patents, and Copyright Committee– Brian Rocha (rocha.51)

Had an Q&A with CIO and head of ERIK – questions we asked about how we can better improve our guidelines to prevent issues where faculty producing research might conflict with outside business interests and the requirements of where/when/how OSU makes itself part of the equation when IP, Patents and copyright issues arise.

### Council on Academic Affairs – Andrew Miles (miles.375)

Resulting from the senate vote on the Chase Center, the senate moved to reject the proposal and subsequently remove itself from future oversight, generally speaking, of the center. The main implication is that CAA will not have direct oversight to review the center and make substantive changes on an as-needed-basis; oversight of the Chase Center will be only within the hands of the provost-a singular person rather than a deliberative body. However, all



programs (certificate, undergrad, graduate, professional) will go through CAA in their creation/revising/sundowning. Similarly, course creation will go through normative OAA processes. CAA is also looking at the evolving landscape of federal/state policy changes as it relates to DEI, international programs, and education. If any student has a story or insights on how policy changes are directly impacting academic affairs, please email (miles.375) me to share with the committee. Our committee can bring in university leaders to address specific or broad concerns.

Normative center review:

First:

-Initial reviews assess the center's budget and performance against pre-set quantifiable targets based on the original proposal and other relevant information.

-The center must respond to the review, detailing achievements or failures in meeting targets and setting new quantifiable targets for the next review period.

### **Subsequent Actions**

Post-review, the reviewing body (such as the CAA) meets to assess the response and recommends one of three options: continue operation, revise direction and support, or close the center.

Recommendations are forwarded to the Provost and, if applicable, the Vice President for Research.

### Start-Up Centers:

Proponents must demonstrate potential for significant external or central funding to the department chairs and college deans before approaching the Provost.

The Provost's approval is contingent upon notification to the CAA, Senate, and Board of Trustees and specifying the criteria for the center to continue.

### Income Streams for Centers:

Centers can generate income through external grants that cover appointments and earn full overhead, and from university annual rate funds for partially or fully paid staff or faculty appointments.

Returns from indirect costs, tuition, and other income based on faculty or staff performance related to the center are proportional to the contribution and involvement of the center's staff in generating these funds.

**Committee Membership**: Lists the members involved in the CAA and other related subcommittees, indicating a diverse representation from various academic and administrative sectors of the university.

Council on Academic Freedom & Responsibility – Jorge E. Clavo Abbass (clavoabbass.1) No meeting.

### Rules Committee – Jorge E. Clavo Abbass (clavoabbass.1)

No relevant update to share.

Library Committee – Gabriel Guzman Camacho (guzmancamacho.1) No update.

**University Research Committee – Tony Annerino (annerino.2) / Andrew Miles (miles.375)** URC received updates about the ERIK website built to track the many ongoing changes impacting availability of federal research funds. This website is continuously being updated as



the situation evolves, and it can be accessed at: https://research.osu.edu/proposaldevelopment-and-submission/sponsors/working-federal-agencies/2025-federal-administration. ERIK also described that all other Big Ten schools charge for IRB review of industry sponsored research work and said that this practice will likely come to OSU sooner than later. Finally, ERIK also said to expect the new Huron IRB online platform to go live on March 20. URC will meet next on March 7.

### Committee on Academic Technology – Tony Annerino (annerino.2)

CAT spent about half the February meeting talking about the ongoing work toward establishing committee bylaws again. The second half of the meeting was taken by the same presentation by interim chief information officer Giner Breon about the ongoing action of the software purchasing working group that I previously reported URC receiving earlier this academic year. A finer detail that became clear in the longer discussion that was available after seeing this same presentation a second time was that the working group recommended to university administration that a new staff position be created explicitly for the long term maintenance and supervision of the software acquisition tools and processes implemented from the working group's procedural suggestions. This request for a new staff position was put on hold until the efficacy of the other suggestions has been determined. Another finer detail that was not made clear upon my first viewing of this presentation is that technology accessibility and going beyond minimum requirements is getting attention that the broader community is probably not aware of as a major recommendation of this working group was related to this matter. CAT will meet next on March 3.

### Council on Enrollment and Student Progress – Thomas Elton (elton.21)

Discussion COAM cases & Al language in syllabi; potential adding Associate Vice President, Institutional

Research and Planning, as a non-voting CESP member; discussion participation rosters, transfer articulation, retroactive withdraws, excused absence policy (excused absences & religious holidays some students may get more days)- Better notes will be updated once meeting minutes are sent out.

### Government Affairs – Bryan Perez Soto (perezsoto.2)

The meeting discussed updates from the local state government, including budgets and bills submitted by the senate (SB1 in particular). In terms of budget, the local government has increased certain funds towards scholarships for undergraduates and kept most of the regular funds on a regular basis. The conversation of SB1 discussed how the university is trying to provide feedback and recommendations to the bill and how it is important to receive feedback from the university body. Great news! The Access Resolution was endorsed by the University Senate at their meeting on February 27<sup>th</sup>. The provost has convened a working group on the Resolution which will continue working on the feasibility of Resolution implementation.

At our February meeting, HWS brainstormed new initiatives on campus aimed at increasing awareness, advocacy, and access for disabled students, staff, and faculty. Our initial plans include launching a webpage of testimonies of disabled members of the OSU community, tied to a sign/flyer campaign on campus drawing attention to the oft invisibilized yet significant disabled population at Ohio State. The webpage would serve as a resource for people to learn more about disability as a lived experience impacted by the in/accessibility of built environments, as well as a general advertisement for the Accessibility Stakeholders' Symposium in October 2025.

Adopting water-saving practices on campus or at home can help reduce your utility bills while conserving a precious resource. Here are some tips to integrate into your daily routine:

• Turn Off Taps. While brushing your teeth or washing your hands, turning off the tap can save up to 8 gallons of water daily<sup>1</sup>
