1. STATEMENT OF PURPOSE

1.1. To effectively advocate and program to ensure that The Ohio State University graduate student experience is the best it can be.

2. SUSPENDED BUSINESS

2.1. Officer and Senator Nominations

2.1.1. Organization and Elections Chair, Allen Cochran.291

Cochran.291: Right now are nominations for Senators and Officers. We are going to start with Senators. The role of a Senator, with CGS, is one of our appointments that the organization makes to the University Senate. We appoint 10 positions/year to the University Senate. Those senators take a pretty prestigious role at the University in order to maintain the graduate student experience the best it can be. Our chair, Sneha Gupta, can you talk a little about time commitment?

Gupta.325: We meet once a month or twice/three times a quarter. I'm assuming it'll be 4 times/semester. Thursdays form 3:30-5:30 and our meetings don't typically last the full 2 hours. It's a great place to hear about new policies implemented at OSU and we get to voice our opinions. We play a pretty big role in many of the committees. So, I wouldn't say it's a BIG time commitment. You are required to be on different committees as a senator but that's your role as a delegate anyway. So I would say maybe 4 hours/month. Cochran.291: There are no restrictions on being both a senator and delegate. If you were to do so, being a Senator serves as your university committee appointment per CGS. There are 10 positions and I'm going to read through these (you may self-nominate or nominate a peer – nominations begin today and extend until Friday, May 4th, our 2nd delegate meeting of the quarter - so if you want to go and look at your schedule next year you can choose to nominate at a later time) the list of senator positions: Arts, education, engineering, food agricultural environmental science, humanities, mathematics and physical sciences, biological sciences, professional biological sciences, business senator, and social and behavioral sciences.

Rao.99: I will open the officer nominations.

Therefore, you are committed to at least 20 hours of work per week in this position. It's a 50% appointment. Also, internal structure of this organization – trying to figure out how to make appointments to committees and keep accurate records, I have also worked hard on the website and trying to fix all of the various errors that you all get.

Gadepally.1: They are the backbone of the organization. Most of you have probably worked with Allen more than you have worked with me. More in charge of the internal structure.

Gadepally.1: To make this effective, we want to have people INVOLVED. If we were to go to the school what happens?

Marshal: if you came, we'd give you a copy of the book, and since most of what we do involves heavy textual analysis and reading anyway, this is a really fun way to use those skills and read to kids! 87% of the

children we work with are African American and 60% of them come from underprivileged homes. All the books are either Newberry award winners or they were elected by the teachers in those schools. Please come and read!

5. UNIVERSIY COMMITTEE UPDATES

Lang.279: if you're interested in seeing the document – some of the concerns that I raised at a recent meeting, while it says it's not going to harm graduate students, they don't talk about how new graduate handbooks will be constructed by program or the new units. They don't talk to GA assignments and right now, in one of the newly configured units, we were deciding those previously and now it will only be 1 person. So advocating for current and new gas in the unit. Also no mention about what's happening with the staff.

Kenitzer.1: sophomore housing transition committee: currently in the research phase, architects just came back with plans. The board of trustees will be voting soon. Beyond that a lot of research is being done on that.

Colin: libraries and information technology: recently been a talk about lack of openness in term of developing content for OSU – nothing for open courseware, participants/community participations have had a hard time getting into Carmen. No official comment period but if you as an instructor have had a problem being inclusive to those not traditional students please send me: odden.2 - they will bring this on to Desire2Learn. Gadepally.1: Commercialization and entrepreneurship here at the university. We're starting a student board, a student version for the student technology officer just kicked off about a month ago. We're trying to get that spirit of entrepreneurship and commercialization across campus. We're working towards that and hopefully you'll be hearing about that soon. If you happen to know people really interested in this please forward them my way – it will be my post-CGS work.

Gadepally.1: I'm on senate steering – they've been talking about parking which is great. Quick question about parking –a faculty sent out a survey to other faculty and had about 2000 response – simple question do you support parking privatization? Id' like to ask that question here informally. Are people here morally opposed to the concept? 2 delegates. Opposed to parking privatization with the current level of information. Still working on the concession agreement. Nothing has been decided. Currently as the document stands 7.5%/year for 10 years and 4% inflation after that. Does anyone feel that they need more information to make a judgment on this? We have not received the bids from the company yet. It needs to be a minimum of 375 million dollars. An independent group of people who worked on the evaluation and they will be presenting this at Senate Fiscal, next Tuesday and will talk about the – the number of 375 million dollars, fiscally, seems okay for OSU. Currently in the process of sending out the concession document to those who have been approved to bid. It should go out in the middle of May.

Cochran.291: update on athletic council – they are undergoing a process to implement a new ticket purchase system for faculty, staff, and students it will be disseminated through departmental fiscal officers to all of you. When semesters begin, the point systems that determine your eligibility to buy tickets is changing. This is maybe not particularly important for all of us but your die-hard professor fans will drastically change for them.

Gadepally.1: there has been a hate crime on campus in the past couple of days. I strongly encourage someone to propose legislation from the Council of Graduate Students against this. We are committed to keep a hate-free campus.

Kuzawa.1: currently a petition sponsored by students and faculty of the Ohio State University in response to the vandalism on the Hale Center.

Crowsley.1: I forwarded that petition to Allen and forward it on to the delegates.

Tan.182: new funding for delegates to host events for their departments. You can meet with your constituents, departments and communicate with them about knowing any concerns. Any CGS delegates can apply for these funds –first come, first served. We only have \$5000 total. We will not fund any more than

\$200. You may apply multiple times –if you want to hold 2 events in Spring quarter. It's a pilot program so every event must be applied for before Friday, May 18th and that event must take place before June 30th. The requirements: just plan your event, fill out the funding request form on page 2 and send the completed form to me at tan.182 and the officers will approve your request and then finalizing the details with your events. I will then notify if you need to add any more details. Next you have to contact your college fiscal officer to have them connect with Rebecca delo.1 who is in charge of student government finances.

Rao.99: page 3 directly instead of direction

Tan.182: it is going to be a reimbursement type program –your department pays up front and then we will reimburse your department. Or you pay and then we reimburse you and third if you decide to hold your event in the union or any student life office, we can just do an internal transfer to the union – it includes Woody's. The third page is just a funding request form. Maintain it less than 8\$/per capita.

Gadepally.1: ideas: work with your department and we'll work with your department to have us reimburse them. This way you're working with the department, which is a great thing. So if you want to do option 3 – you can work with Rebecca to order pizza's from Woody's downstairs and take the pizza's with you. Talk to Rebecca before you spend \$200 if you do it yourself. No alcohol!

Cochran.291: it's super pilot and experimental. We're open to anything as long as it follows student affair guidelines for eligible expenses.

Gadepally.1: June 30th – end of this fiscal year – you will see on the blog soon and in an E-mail highlights of the past year and this fill-in pdf. So for next year – is there going to be a delegate can only get one per quarter/one per year.

It's likely that we may have 2 or 3 meetings during a summer, probably not four but if it's written in there for sake of the institution it would look good on our part.
