#### 3. OFFICER UPDATES

- 3.1. Treasurer
  - 3.1.1. The Ray Travel Award Funding Period 4 2017-2018 received 80 applications.
  - 3.1.2. The CGS Awards Ceremony will be March 29<sup>th</sup> 5pm 7pm in the Barrister Club, all Delegates and Senators are invited.
  - 3.1.3. Montoya.29 announced that she is graduating and will be leaving Ohio State after this year. Congratulations to Amanda on her graduation and new job!
- 3.2. Secretary
- 3.3. Vice President
  - 3.3.1. Walterbusch.1 asked that delegates, senators, and officers turn in their name tags at the end of each meeting. She mentioned that new nametags were printed

- and anyone missing a nametag should create one. New nametags will be made for those who turn in edited nametags. Outside of existing nametags, those with mistakes, and missing ones that are created at the meeting via marker and paper, there will be no new nametags printed by the end of the meeting.

- 3.3.3. Walterbusch.1 offered a friendly reminder that the Senator elections are also coming up, so if you are interested in that please reach out to a Senator who has a yellow name tag and ask them about what that entails.
- 3.3.4. Walterbusch.1 also reminded everyone that you can apply for an officer position as well and we know for sure that there will be an opening specifically in the Treasurer position and potentially others.
- 3.3.5. Walterbusch.1 reminded everyone to submit their committee updates.
- 3.3.6. Walterbusch.1 is looking for some judges for the Hayes Forum (specifically business and FES). You can nominate people anonymously! Also, we are looking for volunteers so please reach out if you are interested or sign up here: http://go.osu.edu/hayeshelp.

- 3.4.4. Wesaw.1 shared that we may need to be aware and prepared to advocate for the Higher Education Act in the future.

#### 5. OLD BUSINESS

#### 6. NEW BUSINESS

- 6.1. ACT 1718 SP001: AN ACT CONCERNING THE AMENDMENT OF THE BUDGET FOR THE 2017-2018
  - 6.1.1. We received about \$12,500 more than we intended so that was redistributed throughout the budget.
  - 6.1.2. There is also an adjustment for the CGS gear that was purchased during the last fiscal budget but hit our budget this year. Encumbrances is money that we attempted to spend last year (that we would have lost otherwise), but actually was spent this year which explains why \$8000 was moved to the marketing committee.
  - 6.1.3. The executive committee met and decided to create a pool of money that is available to any committees in need with some of the extra money. Therefore, if a committee needs additional monies for an event they can request this extra funding. So, if you are on a committee and have an idea, please reach out to your committee chair so that we can use this!
  - 6.1.4. Montoya.29 also explained that she is working with Coca Cola to get additional funds for next year.
  - 6.1.5. A question was raised regarding the purpose of adjusting the budget versus waiting until next year and learning from mistakes of going above or under budget and the point was raised that it aligns with the procedures in the governance to amend the budget when there are any substantial changes to protect and inform the body.
  - 6.1.6. A question was raised regarding how individuals/committees will get this money and whether it needs to be added to the Act, but the consensus was that this did not belong in this Act and that there was a goal to develop some kind of procedure to request the funds.
  - 6.1.7. Connolly.93 motions to approve the Act.
  - 6.1.8. Stone.655 seconded the motion to approve the Act.
  - 6.1.9. The motion to approve the Act carries with one objection.
- 6.2. Marketing Committee Recommendation for Meeting Minutes
  - 6.2.1. Connolly.93 explained that Robert's Rules of Order suggests that we capture the essence of the meeting minutes instead of what was explicitly stated. Therefore the marketing committee is in favor of using the Robert's Rules of Order because it would reduce the time spent on grammar errors in the minutes, reduce the burden on the volunteer secretary, and reduce the burden of consciousness that comes with direct transcription. However, they raise the suggestion that if you speak and want that to be directly transcribed by stating in the meeting that you would request "let the record state" in the meeting. If you have any suggestions or feedback regarding how you would like the meeting minutes recorded please reach out.

# 7. Delegate Concerns

7.1. Monday February 5th please join us for the Work in the World event

- 7.2. A concern was raised regarding graduate student sick leave, Wesaw.1 agreed to look into this and follow up and a delegate stated that you are guaranteed 2-3 weeks off.
- 7.3. A concern was raised regarding the University child care services expenses, the facilities are also older, and the food was not of particularly high quality or health as compared to previous institutions in other states. An additional concern was raised that students had to keep their children over winter break. A recommendation was made to reach out to the Senate prior to next week and Wesaw.1 agreed to take this up to the Office of Student Life. Another recommendation was made to look at OSU's Child Care website where there's information about state assistance.
- 7.4. Whitaker.105 requested anyone who has advice on establishing Ohio residency to reach out to him or the Government and Student Affairs Committee so that we can facilitate other graduate students working to establish residency.
- 7.5. A concern was raised regarding the opt-in and opt-out policy for OPERS and whether or not we can identify easier ways to get information about the programs and about how to opt-in or out. A suggestion was raised to get a group or committee together to address this issue as well.
- 7.6. An additional concern was raised regarding opting out of STRS, Wesaw.1 said he will look into more information on this and how we can advocate on behalf of students.

Article I Sections 2 through 3 of the Constitution of CGS is as follows:

Section 2.1: Units of representation - Units of representation of CGS shall be determined by the Organization and Elections Committee. Units will be based on, but not necessarily limited to, graduate program areas: exceptionally large programs may be split and exceptionally small ones grouped.

Section 2.2: Apportionment - CGS shall be composed of not more than one hundred fifty voting delegates and no fewer than one hundred thirty. The number of delegates per unit of representation shall not exceed twelve. Each spring, the Organization and Elections Committee shall apportion these positions to the graduate programs on the basis of autumn semester enrollment. Each unit of representation shall have at least one delegate. Each regional campus with graduate representation shall be allotted one delegate seat. The number of regional seats shall not exceed five."

Section 3. Whereas, in addition to the above criteria stipulated in the CGS Bylaws, this act has apportioned delegates seats based upon a ratio of 99 graduate students equating to 1 delegate seat, and a maximum cap of 4 delegate seats per unit of representation, as was determined by the Organization and Elections committee. This is to ensure that the total number of seats falls within the 130 minimum and 150 maximum seat range and also to meet the criteria of being no more than 12 delegate seats per unit of representation stipulated in the CGS Bylaws:

1-99 Graduate Students = 1 Delegate Seat 100-199 Graduate Students= 2 Delegate Seats 200-299 Graduate Students= 3 Delegate Seats 300 and Above Graduate Students= 4 Delegate Seats

  - A. Assess how the opioid epidemic is affecting graduate students
    - Have reached out (twice) to the Collegiate Recovery Community; no response
    - Will reach out to Dean Melnyk for her input
  - B. Compile and identify what efforts are already in place on campus to tackle this problem.
- 4. Improve scheduling procedures and policies for health services appointments for graduate students
  - Jennifer and another member of the committee, Kara Braunreiter, attended two meetings with members of the Counseling and Consultation Services Staff including the director of the center.
  - We raised the concerns about graduate students being told that they should meet with their councilor weekly, but then only allowed to schedule 1 meeting at a time, resulting in several weeks wait time in between appointments. (This was brought as a delegate concern.)

- CCS assured us that the 1 scheduled meeting practice is not a policy that they enforce; however, many councilors do follow that practice because they reevaluate the needs of the student at each meeting and adjust their appointment schedule accordingly. They admit that wait times can be 1-2 weeks for an appointment, but also pointed out that they consider themselves a short term service and if they have a student who they anticipate needing long term, weekly appointments that that individual would be referred out to someone in the community.
- CCS also wanted to bring awareness to some alternative and emergency counseling services that they offer, should a student be unable to get a weekly or immediate appointment with their councilor due to high demand. These services include:
  - Daily group counseling Sessions are held daily in focus groups designed around the most common concerns of students. Groups are also available exclusively for graduate students. These are drop-in sessions so no appointment is needed.
  - 2. Emergency appointments They reserve a number of appointment slots each day for emergency appointments. If a student is in distress they can call for an emergency appointment, but they may not necessarily get the councilor they are already seeing if that person doesn't have any emergency slots available.
  - 3. 24/7 emergency hotline There is a emergency hotline that students can call 24/7 to talk to a trained councilor on the other end.
- We consider this issue to be resolved and will not be following up further as a committee unless an additional concern arises.

# RESOLUTION 1718- SP-001 A Resolution to Support "Race, Ethnicity, and Gender" as a Foundations Course for the General Education Curriculum at the Ohio State University Whereas preparing a diverse student body to be "leaders and engaged citizens" is part of The

Ohio State University's mission statement1; and

Whereas The Ohio State University's General Education program intends "the development of knowledge, perception, attitudes, and skills necessary to understand society's traditions and past, its accomplishments and aspirations, its relation and responsibility to the natural world, its diversity and plurality, and its problems and needs"<sup>2</sup>; and

Whereas The Ohio State University defines the goal of its General Education requirements as encouraging and helping "students to attain a sense of self within society"; and

Whereas the university's General Education requirements are presently under review and intend "to develop and refine certain qualities, abilities and characteristics that prepare its students to be engaged, resilient, and adaptable citizens and leaders for life; to develop an engagement with and ability to apply a range of important modes of human thought and inquiry; and to examine significant aspects of the human condition in local, state, national and global settings today, and in the foreseeable future"<sup>3</sup>; and

Whereas the proposed revisions to the university's General Education requirements advise that undergraduate students "describe and analyze U.S. institutions, the cultural traditions that have formed and informed the nation, and the pluralistic nature of U.S. society" as expected learning outcomes; and

> Whereas the proposed revisions to the university's General Education requirements also outline the ability to "explicitly examine and value various expressions and implications of diversity, both within and beyond U.S. society" an expected learning outcome; and

Whereas adopting "Race, Ethnicity, and Gender" as a Foundational requirement for undergraduate students will support the mission statement of The Ohio State University; and

Whereas a number of universities, including Big Ten institutions such as University of Michigan<sup>4</sup>, University of Illinois<sup>5</sup>, University of Minnesota<sup>6</sup>, and University of Wisconsin<sup>7</sup> have already established General Education curricula that prescribe Race, Ethnicity, and/or Gender as requirements for their undergraduate students; and

Whereas adopting "Race, Ethnicity, and Gender" as a Foundational requirement for undergraduate students will thereby bring us in line with key peers among the Big Ten universities; and

Whereas adopting "Race, Ethnicity, and Gender" as a Foundational requirement for undergraduate students will better equip students to engage courses in the category of "Citizenship for a Just and Diverse World" in more profound ways; and

Whereas the Graduate Student Council's purpose is "To effectively advocate and program to ensure that The Ohio State University graduate student experience is the best it can be"; and

Whereas graduate students at The Ohio State University provide instruction for undergraduate courses, including courses offered to satisfy the General Education curricular requirements of the university; and

Whereas the composition and content of courses administered by and taught by graduate students is a central concern of those students;

Therefore, let it be resolved that the Graduate Student Council supports the inclusion of at least one 3-credit hour course in "Race, Ethnicity, and Gender" as a Foundations Course requirement for the revised General Education curriculum for undergraduate students at The Ohio State University; and

Let it further be resolved that the Graduate Student Council affirms that incorporating this Foundation into the General Education curriculum will enhance The Ohio State University's ability to attract and retain more students from underrepresented groups precisely because it shifts the charge for understanding their underrepresentation from members of those groups to the whole of the university's shared academic society, making all members of the university participants in addressing such concerns; and
