- Omicron Covid variant – There is no formal update or policy. But as we learn about this, Nick will be sending out emails as information comes out.
- Covid Aid dispersement – no longer requires any documentation
- Heather Daly.# The Psychology Department received an email this week regarding our regular summer funding being discontinued. Previously summer funding was guaranteed after the 1st, 2nd, and 3rd years providing you reached your milestones. Now the 2nd and 3rd year summer funding is being discontinued, which is going to negatively affect a lot of students, especially those without other financial support. I was wondering if other departments are encountering similar issues, and how they're handling that? I am concerned that this decision will be especially harmful to students most in need.
