#### 1.1. Statement of Purpose

**1.1.1.** To effectively advocate and program to ensure that the Ohio State University graduate student experience is the best it can be.

## 3. Guest Speakers from University Offices

## 3.1. Office of Distance Education and eLearning (Liv Gjestvang.1)

- **3.1.1.** Suicide is the 2<sup>nd</sup> leading cause of death among young people aged 16-19 and many people who have mental health concerns are not seeking any help.
- 3.1.2. OSU launched a new wellness app as part of the Digital Flagship Initiative. The Suicide Prevention Task Force started working on the conceptual development of this app last summer. The project was driven by direct discussion and feedback from students about issues and experiences accessing mental health help and resources on campus.
- 3.1.3. The app has several features: An "Explore" tab that features content that will change and update to be relevant. The "Support" tab is designed to address specific concerns that students might experience and then directs them to the appropriate resources (out of 130 possible options) on campus. The "My Wellness" tab allows students to add goals and track their progress. Finally, there is a "My Crisis" tab with direct contact information for helplines and immediate help.

## 3.1.4. Questions from delegates:

- Khamees.5 asked how the office is getting the word out effectively, especially with the stigma associated with getting mental health help.
  - The ipads given to undergrads are preloaded with this app and all students
    can either choose to use it or not. The team is focusing on spreading the word
    about the app through student leadership in order to make grad students
    aware of it as well.
- Clott.1 asked whether this app can address the unique needs of graduate students.
  - Because the app is personalized, students are identified as graduate students

- when they log in and can be shown different content. This content does not currently exist, but this is something that the team is interested in working on.
- Pauley.66 asked what the financial contribution from the university was to develop this app in relation to the potential cost of adding more personnel to Counseling and Consultation Services, which has been under-staffed for years.
  - The development team came from OSU and the cost of the project was essentially zero because of a partnership through the university.
- Shah.1285 asked if the team can share future numbers with CGS about how this app is being used.
  - Yes, ODEE will likely publish a report about usage of the app with whatever data can be publicly shared.

#### 4.1. Minutes from January 10, 2020

#### 5. OFFICER REPORTS (as submitted in Delegate Meeting Packet)

#### 5.1. President (Post.144)

- 5.1.1. On April 4th, CGS is participating in the "Out of the Darkness" walk to engage and support people affected by suicide. CGS is a well-being sponsor and contributed financially to this event. Additionally, CGS has a team that will walk together. Please join the CGS team by signing up even if you can't be there in person (the website will ask if you want to donate but there is no need unless you want to).
- **5.1.2.** The Presidential Search Committee is hosting an open forum next week on February 11<sup>th</sup> at 6:30pm to gather information about what the search committee should be looking for in potential candidates. This forum is open to all graduate and professional students. You can also give feedback and make nominations on the Board of Trustees website.
- 5.1.3. Haynes.242 and Post.144 met with Dave Wiseley (Chief Financial Officer for Student Life) about the issue of grants reimbursement timelines. They also discussed possible places to find additional funding for grants in the future.
- **5.1.4.** The Graduate School is crafting an honor code and wants input from graduate students. Feedback or ideas about this should be sent to Post.144.
- 5.1.5. Clint Woods recently resigned from his position as the Director of Strategic Partnerships in the College of Food, Agricultural, and Environmental Sciences. Last semester, CGS had passed a resolution requesting more information about his hiring and expressing concern about his environmental record.
- 5.1.6. The formal language of the graduate ombudsperson resolution is still being workshopped but will be presented at the February meeting of the Steering Committee. After that, it will be referred to the Rules Committee and then come back to Steering to be presented to the full Senate in March. We anticipate having this position filled by the start of the next academic year.

## 5.2. Vice President (Bauman.193)

- **5.2.1.** The 2020 Hayes Forum needs proctors on the day of the event so please consider volunteering. The forum still needs judges in most categories, especially the arts encourage faculty you know to participate!
- **5.2.2.** Officer elections are coming up next meeting (applications are due by March 4th). Encourage your peers to run for these positions because word of mouth is the best way to fill delegate seats. Senate elections will happen at the April meeting.

#### 5.3. Treasurer (Haynes.242)

5.3.1. We have spent just over \$5,000 on food so far this year which is less than half of what was spent in all of last year (\$13,000) and we have only 3 meetings left.

- **5.3.2.** The Delegate Outreach Grant still has money left so please apply for these!
- **5.3.3.** Funding period 4 of Ray just closed and just over 75 people applied. Applications are being judged now and winners will be notified by the end of the month.
  - Zamanian.2 asked whether it is true that more hours of service makes your application stronger and why do they not ask the PI to verify that the student has done all of this service.
    - The full name of the award is the Ray Travel Award for Service & Scholarship.
       Service is a crucial part of the application and contributes to 40% of the final score. Both quantity and quality are considered in this section.
    - In many cases, the faculty member submitting a recommendation has no idea what service the student is involved in. There is no way to verify that all listed hours are real, but applicants must justify how they spent their time. This cuts down on false reporting. Service is defined as any activity not required as part of your graduate education and for which you were not paid.
  - Lynch.189 asked how many people will be funded this period.
    - This is unclear now. It will depend on the final scores from the judges.
  - Pierre.77 asked how students outside of CGS can become judges.
    - Any graduate student is welcome to serve as a judge. All they need to do is email Haynes.242 before the application deadline of any funding period.
  - Scaltitri.1 asked why there are so many applications left unfinished?
    - Some decide not to finish the application because of the amount of work it requires and some don't leave themselves enough time to finish before the website closes.
- **5.3.4.** The demographic report has now been published.
- **5.3.5.** Haynes.242 suggested that all treasurers for the student governments should have to do formal training because handling such large budgets is difficult and has a steep learning curve.

#### 5.4. Secretary (Light.109)

- **5.4.1.** Funding period 4 of the Career Development Grant is closed and judging has begun. Winners will be notified by the end of the month.
- **5.4.2.** The application window for the Global Gateway Grant is open until February 28<sup>th</sup>.
- 5.4.3. CGS will be hosting an awards ceremony on Monday, April 13<sup>th</sup> from 5-7pm in the Performance Hall of the Union. This event will recognize all winners of the Ray, Career Development Grant, and the Global Gateway Grant over the past year. Additionally, we will be thanking all current delegates, senators, and officers of CGS for their service this academic year and welcoming students who will be taking over these positions. Finally, we will award several CGS awards to recognize students and faculty who have gone above and beyond both within CGS and in the greater OSU community. **6.3.1.** USG, IPC, and CGS have been working together on a Diversity and Equity campaign. The campaign has been launched on our Twitter and Facebook pages. We are waiting on a final cut of the video from WOSU and then that will be posted as well.

#### 7.1. Delegate Concerns

- 7.1.1. Lo.208- There is circulating petition urging the Career & Counseling Services office to offer urgent walk-in services. This will be discussed at a meeting next week of the Mental Health task force. Please sign the petition if you are able.
- 7.1.2. Datar.10 asked if there is an upper limit to what Lyft can charge students for rides. With the partnership, drivers are not supposed to sur-charged during busy times, but students have experienced much larger ride fees than what has been advertised.

#### 8. NEW BUSINESS

# 8.1. Resolution 1920 SP-009: A Resolution Calling for the Expansion of Automatic External Defibrillators on Campus

**8.1.1.** Beauregard.13: The number one predictor is survival during a cardiac arrest is the time to apply and use a defibrillator. Less than 20% of the 631 buildings on campus have even one defibrillator. Even in buildings that have one, it was difficult to find and was not known about by people who work there.

#### 8.1.2. Questions:

- Pierre.77 asked if it would be good to include a mandatory training component as part of this resolution, especially if people are not familiar with how to use them.
  - Beauregard.13 answered that there is AED training available on campus through the RPAC.
  - Edison.22 pointed out that each AED has very clear instructions.
- Drayton.18 asked if there are any other laws or building codes that require an AED.
  - The answer is yes for federal buildings but not for state buildings.
- Haynes.242 asked if there are any legal protections for anyone who uses a defibrillator incorrectly or harms someone.
  - You are protected by both Ohio and federal law.

## 8.1.3. Discussion:

- Uanhoro.1 suggested that it would be good to add an amendment that asks for AEDs on public transportation on campus as well.
  - Beauregard.13 rejects friendly amendment suggestion because he thinks it will be asking for too much and the university won't comply.
- Beauregard.13 proposes an amendment to Line 47 to replace "in the lobby" with "near the main entrance"
  - Amendment passes.
- **8.1.4.** Clott.1 moves to vote on the resolution.
- **8.1.5.** Seconded by Shah.1285
- 8.1.6. Resolution passes

## 8.2. Act 1920 SP-006: An Act Establishing the 2020-2021 Delegate Apportionment for the Council of Graduate Students

**8.2.1.** Bauman.193: These numbers are based on a report provided by the graduate school. This act mainly focuses on changing names of delegate seats whether the program names have changed and removing seats for departments that no longer exist.

#### 8.2.2. Questions:

Drayton.18 asked why "Engineering Education" has been changed to "Engineering

Administration; Engineering Education; Global Engineering Leadership" as these two additional programs are online-only masters programs and are not housed under the Department of Engineering Education.

- Williams.6571 asked why Wooster is not listed as a regional campus.
  - OSU does not consider Wooster a regional campus and so they do not get their own seat as the other campuses do.
- Blackburn.243 asked if the numbers are accurate because her department (Anatomy) has more students than is listed.
  - The numbers are taken from a report assembled by the Graduate School.
- Uanhoro.1 asked if the regional seats are ever filled.
- Williams.6571 asked why there is a cap of 4 delegates for all departments.
  - Per our by-laws, we can only have 150 seats total but using this met. We cannot go over 12 seats total for any department but the number of seats allotted is based on the historical participation in CGS.

#### 8.2.3. Discussion:

- Beauregard.13 motions to make an amendment to change the name of "Allied Medicine" to "Health & Rehabilitation Science MS" and keep the seat.
- Amendment passes
- Anderson.3449 proposes an amendment to change "Communications" to "Communication".
- Amendment passes.
- Sarich.6 proposes an amendment to change "Health & Rehabilitation Sciences" to "Health & Rehabilitation Sciences PhD"
  - Vieria.31 points out that this sets a precedent to give every program two seats if they have a separate masters and PhD program.
- Amendment fails.
- Holt.351 proposes an amendment to change "College of the Arts" to "College of Arts and Sciences" with subsets for the different department such as humanities, arts, math, and physical sciences.
- Amendment passes.
- Shah.1285 moves to reconsider the first passed amendment.
- Shah.1285 proposes to change the amendment.
- Shah.1285 rescinds his motion.
- **8.2.4.** Slechta.3 motions to refer the act back to the committee and have them accept public comment before presenting it again at the next delegate meeting.
- 8.2.5. Motion passes.

## 8.3. Officer Nominations (Bauman.193)

- 8.3.1. Sarich.6 nominates Post.144 for President.

## Hello CGS Delegates,

As we reach the middle of the spring semester, I hope you all are doing well and taking care of yourselves, mentally, physically, and emotionally. This can be a very stressful time of the semester balancing your academic, professional, personal, and social lives. If you're ever in need of any support, be sure to check out OSU's Counseling and Consultation Services (CCS) [ccs.osu.edu // 614-292-5766] or reach out to a friend/family member. I wish you all the best as we began to approach the second half of the semester, Go Bucks!

## **CGS Budget Update**

As of February 28, 2020 CGS has spent \$157,374.48. A more detailed list of expenses by category is attached. As you review the budget, I would like to highlight a few things:

- The RED NUMBERS indicates that particular budget line is over budget. You will notice this is the case for Ray, CDG, and Technology. Ray and CDG will not end the year over budget, instead at the end of the year it will balance out due to students not using the full amount they are funded, thus we have to overfund these grants to ensure we disburse all of the allocated money in a given year. This is explained in the Grant Resolution that is being put forth today, hopefully this new resolution will help us better budget for this issue.
- As previously mentioned, the technology cost is extremely high. We will be reimbursed
  for those cost at the end of the year, so in reality they are not actual cost, but for
  transparency purposes I felt the need to display it. The Office of Student Life has
  confirmed that it will occur by the end of the fiscal year. The funding will be transferred
  over from Trademark and Licensing.
- Committee chairs are highly encouraged to start spending their budgets down. We cannot carryforward more than 10% of our budget, per University guidelines.
- I expect more cost to hit our budget between now and spring break. Additionally Hayes budget will be exhausted by the time of the next budget update and some other committee upcoming programs/events spending will be reflected on that budget update.
- Welcome Week Autumn 2020 promo items will be purchased using this year budget due to purchasing windows issued by the Office of Student Life, last month.

## **Delegate Engagement Fund**

Please continue to take advantage of the Delegate Engagement Fund, you may request up to \$200.00 per event. We will try to spread those funds out across departments and colleges, to ensure everyone has the chance to use this grant. Remember all delegate engagement fund requests must be sent to Jack Brandl.8 AND myself (haynes.242).

Please remember there is a **three-week requirement for submitting Delegate Engagement Fund request**, to ensure we have proper time to review them, make a decision, and forward them on to Teresa so she can then forward them on to the business office for processing.

## **Ray Travel Award**


**Funding period IV window has closed.** This period we funded 16 students, representing 13 departments across five colleges. Overall this year, we funded 49 students. Our judges reviewed over 200 applications this year. I would like to send an additional HUGE THANK YOU to anyone who served as a judge this year.

## **Coronavirus (COVID-19) and Grant Awardees**

As you all may know already the coronavirus, officially known as COVID-19, is rapidly spreading across countries. Some students who have been awarded grants this year are being directly impacted by University travel restrictions that went into place last month or are siding on the side of caution when it comes to traveling to international conferences in countries impacted by the virus (not under University restriction). Therefore, to support all awardees we will work with any awardee who was scheduled to travel to a location impacted by the coronavirus. They will have 12-months after their original deadline to use their grant. We are in talks with Student Life to ensure their funding is set aside for them.

## **Student Family Housing Update**

We recently received news from the Office of Government Affairs that in <u>Senate Bill 120</u>, which was recently passed on January 31st, 2020 and will become effective May 1st, 2020, there is an amendment that reads as follows:

"Sec. 3345.55 (D) Any campus housing facilities included in a lease agreement entered into under this section, including campus housing facilities constructed by a nonpublic vendor under a lease agreement, shall retain an exemption from property taxes and assessments in accordance with division (M) of section 3345.12 of the Revised Code."

In my understanding, this is the state tax that administration had mentioned at previous Buckeye Village meetings that added an additional ~\$200 cost per unit that would've been passed down to

students making the 2017 RFP/Development plan financially unfeasible. Now that this tax is no longer at play, such a development would now be considered exempt under the above change. We have pushed this issue forward and have heard that Dr. Shivers is raising the issue with Mike Papadakis, CFO, and eventually to the President's Cabinet. Additionally, I followed up with Jay Kasey in Administration & Planning who was optimistic that the bill passage would allow for possible investment of a new multifamily student housing facility.

The Parenting and Pregnant Student Working Group is continuously evaluating the current resources provided to students with families including child care, food insecurity, and housing. This issue will be brought up in that group for further consideration, as well as a formal request will be sent to the Provost to form a committee that will comprehensively evaluate and produce a new proposal.

# An Act Establishing New Policies & Procedures for Grants Administered by the Council of Graduate Students

Author: Sarah Light.109, Secretary & DaVonti' D. Haynes.242, Treasurer Sponsor: Grants Administration and Ray Travel Award Committees

**Section 1.** The purpose of this act is to update the policies and guidelines for administration of the Edward J. Ray Travel Award for Scholarship & Service and the Career Development Grant, in line with decisions made by the respective committees. These changes will clarify language used in the written guidelines and standing rules for each of these awards. These updates will ensure that all CGS-funded awards follow the same eligibility and funding rules to reduce confusion and ensure fairness for applicants. All updates and policy changes will take effect beginning in Funding Period 1 of the 2020-2021 academic year.

Section 2. The current award policy for the Ray Travel Award states that once a student has won the award, they are not eligible to apply again for the remainder of the fiscal year and the entirety of the following fiscal year. The current policy for the Career Development Grant states that a student may only win the award once per academic year. Both policies will now state that a student who has won either of the awards will not be eligible to apply for the same award again for the remainder of the fiscal year and the following fiscal year. This policy will be applied separately for each award. This will ensure that the same people are not receiving the award multiple years in a row.

Section 3. The current policy for both the Ray Travel Award and the Career Development Grant states that a student will not be awarded more than the maximum amount (\$1,000 for the Ray; \$350 for the CDG) in a fiscal year. This means that if a student applies for and is awarded less than the maximum amount, they are eligible to apply again for the remainder of the award up to the maximum in a subsequent funding period of the same fiscal year. As such, for budgeting purposes, each student is recorded as having been awarded the maximum amount of the award, even if they were actually awarded less than the maximum. This results in money left over in both the Ray Travel Award and Career Development Grant budgets at the end of the year that has been accounted for but not actually used. Both policies will be updated to state that applicants will be awarded and reimbursed up to the maximum allowable amount. Applicants who do not use the full amount in the funding period for which they have won will no longer be able to re-apply for the remainder of the funds.

**Section 4.** Neither the Ray Travel Award nor the Career Development Grant have a current policy addressing the number of times any student may receive the award. Funding guidelines for both grants will be updated to include a stipulation that any student may only win each award a maximum of 3 times per graduate degree pursued. This 3-time maximum shall be summed separately for each award. Students pursuing multiple degrees will be able to win each award a maximum of 3 times for each non-concurrent degree that is pursued.

 **Section 5.** Neither the Ray Travel Award nor the Career Development Grant have a current policy addressing the number of applications a student may submit in a single funding period. Funding guidelines for both grants will be updated to include a stipulation that any student may only submit one application per funding cycle. In the event that a student submits more than one application per funding cycle, the chair will randomly select the application that is judged. If an applicant has multiple activities or expenses planned in the same activity window, they may include these in a single application for either award.

**Section 6**. Historically, applications for the Ray Travel Award have been judged by a minimum of 5 independent judges because of a Yes/No judging system. This system is no longer used and as such, this

## **Council of Graduate Students Career Development Grant**

By offering grants of up to \$350 each through the Career Development Grant program, the Council of Graduate Students (CGS) provides an incentive for graduate students to prepare for placement into their chosen field while attending OSU. These grants will subsidize the expenses incurred by the activities outlined in the application.

Applications will be evaluated based on the strength of presentation of professional goals in the Career Development Plan, explanation of the relevance of proposed activities in the Statement of Intent, and demonstration of experience toward reaching stated goals in the resume.

#### **Guidelines:**

- Applicants must be enrolled in the Graduate School at The Ohio State University during
  the semester in which the applicant submits grant application. Expenses incurred during
  an academic semester in which the applicant is not enrolled in classes require the
  students be enrolled in the immediately preceding semester. In the case of summer
  conferences, applicants must be enrolled in the summer term or the subsequent autumn
  semester.
- In addition, the applicant must be in good standing with the Graduate School, which
  requires current or previous enrollment in Graduate School at The Ohio State University.
- Applications must be submitted prior to the start of the term in which the anticipated activities will take place. Activities occurring between semesters are considered to be part of the previous semester.
- Grant recipients will be reimbursed after the activities have taken place, through a check issued by The Ohio State University or through direct deposit.
- In order to obtain reimbursement, ORIGINAL RECEIPTS (showing payment confirmation) must be provided to CGS.
- No applicant will be awarded more than \$350 in CGS Career Development Grant funds per academic year.
- Previous award winners must disclose all previous Career Development Grant awards.
   Failure to do so will automatically disqualify applicants.
- The application must be received by CGS before the deadline. Late or incomplete applications will not be considered.
- With consent of the applicant, the "Submission Materials" of any grant recipient may be made available by CGS for prospective applicants to review as a model of excellent career preparation.
- The CDG does not give out scores (which are normalized), whether those of an individual or of all applicants.
- All expenses and activities must be completed prior to graduation.

## Standing Rules

Council of Government Students Standing Rules, The Ohio State University

## The Edward J Ray Travel Award for Scholarship and Service (RTA) Purpose:

The purpose of the Professional Development Fund (PDF) is to provide travel grants to qualified graduate students, fostering their professional development by allowing them to present their research at domestic and international conferences. The PDF sets itself apart from other funding sources in that it recognizes graduate students for their service to the University and to the wider community.

## **Committee Composition:**

The Ray Travel Award committee shall consist of: 1) CGS Treasurer serving as chair, 2) At least four students. In addition, up to three faculty members may be appointed by the CGS Vice President.

A combination of students and faculty members from at least three colleges shall constitute a quorum for any individual judging round.

## Judging:

The PDF is a competitive program, and as such, no more than forty percent of the applications received in a given year may be funded. Each funding cycle, applicants shall apply using a form approved by the PDF committee that takes into account at least the following factors:

- 1. The applicant's ability to convey the importance of the research being presented
- 2. The relevance of the proposed presentation to the applicant's professional development
- 3. The applicant's service to their department, the University as a whole, and the wider community
- 4. Faculty statements of support for the applicant's research.
- 5. Applicant's previous funding history through the Ray Travel Award.

The Ray Travel Award Committee may set the award amount to any amount not to exceed \$1000. When the Committee changes the Award amount, the Treasurer must ensure that promotional materials regarding the Award, including but not limited to, information on the CGS website, is update to reflect the new amount at least four weeks prior to the Application Deadline for the Award period in which the Committee desires the changed amount to take effect.

The committee's decisions regarding Awardees cannot be appealed.

## **Eligibility:**

Applicants must satisfy at least the following criteria to be awarded funding:

- 1. They must be graduate students in good standing with the graduate school and their program.
- 2. The application must be submitted prior to conference attendance.
- 3. Student is ineligible if student received the Ray Travel Award in the previous fiscal period.

#### Allowable Expenses and Reimbursement:

All PDF awards are paid out as reimbursements. All relevant university policies shall be observed in determining allowable expenses. Reimbursement shall not occur until the recipient has provided CGS with both an acceptable form of proof of conference presentation and acceptable receipts.

## **CGS Distinguished Service Awards**

**Purpose**. The Council of Graduate Students presents the CGS Distinguished Service Awards to recognize those students, staff, faculty, administrators and community members who have rendered exceptional service to graduate students at The Ohio State University on a yearly basis.

**Application Requirements**. Nominations must be submitted to the Executive Committee by the 31st of March, or a later date set and announced by the

Executive committee and include the following: 1) the name of the nominee, 2) the nominee's address, telephone number, and e-mail address, 3) the nominator's name, address, telephone number, and e-mail address, 4) the name and contact information of one additional reference for the committee to contact, 5) a letter describing the individual's qualification for the award; and 6) a copy of the nominee's resume, vita, or equivalent.

**Recipient Selection**. The Executive Committee shall select no more than three recipients in any one year. Individuals shall be eligible again for consideration five years after receiving an award. No voting member of the Executive Committee may receive the award.

## **Guidelines for Organizations Seeking CGS Co-Sponsorship of Events:**

**Purpose**. The purpose of co-sponsorship is to broaden the opportunities of graduate students by enabling groups such as University departments, student organizations, and non-university groups to partner with the Council of Graduate Students to provide graduate students with unique educational, cultural, and social opportunities. Co-sponsorship is more than just a cash subsidy and should entail a partnership in resources and planning between the Council and the requesting organization.

## **Application Requirements:**

The organization seeking co-sponsorship must provide the following information to an appropriate standing committee of the Council (not including the Executive Committee): an explanation of the event, focusing on the benefit to graduate students at Ohio State; the event's budget; the list of other confirmed and expected co-sponsors; the specific dollar amount desired from CGS, not to exceed \$500; an explanation of how CGS will be involved in the event; the number of volunteers that CGS will be expected to contribute to the planning committee and to the event itself; the methods that will be used to assess the event; the means by which CGS will be recognized as a co-sponsor of the event; and the anticipated number of graduate student participants at the event.

## **Guidelines for Committee Approval of Co-Sponsorship:**

The standing committee that receives a request for co-sponsorship shall take the following factors into account when reaching a decision on co-sponsorship: • the expected impact of the event on graduate students; the event's relevance to the committee's goals and objectives; the opportunity for substantial contribution to the planning and implementation of the event; and the event's relevance to the overall goals and objectives of the Council of Graduate Students. The standing committee may choose to provide non-monetary resources as the exclusive form of co-sponsorship of an event. The standing committee's determination is final and can only be appealed by a resolution to the Council of Graduate Students sponsored by at least five voting members of the Council explicitly stating the budget line that will provide the funding.

## Eligibility:

Applicants must satisfy the following criteria to receive monetary co-sponsorship:

In the case of a student organization (excluding Inter-Professional Council and Undergraduate Student Government), the organization must be registered and have exhausted all available Council on Student Affairs funding provided through the Student Activity Fee;

In the case of University departments or external organizations, the event must be primarily designed to serve graduate students; and Events for which co-sponsorship is requested must fit within the overall goals and mission of the Council of Graduate Students.

The 2020 – 2021 Delegate Apportionment document was available for public comment from the 2019 – 2020 delegate body at two different points throughout the restructuring process. These interdisciplinary programs have their own units of representation as 40 they belong to multiple departments. 41 42 Delegate seats were distributed via a modified version of the Huntington-Hill Method. The modification is that the number of seats per unit of representation is capped at 4. For 140 delegate seats, with 10,575 graduate 43 44 students, this method indicates the following levels of representation: 45 46 1-105 Graduate Students = 1 Delegate Seat 47 106-182 Graduate Students = 2 Delegate Seats 48 183-258 Graduate Students = 3 Delegate Seats

Greater than 258 Graduate Students = 4 Delegate Seats
