1. President's Report

- 1.1. BuckiServe is sending a representative to come speak to the delegate body at our next meeting. We will also be hosting someone from the Office of Institutional Equity and Student Legal Services. Provost McPheron will come to speak at our February meeting and we will be working on a prepared list of questions for him.
- 1.2. There is an initiative being put together to start in late January across many offices including OIE, CGS, IPC, and Student Life to discuss issues involving students with families.
- 1.3. Post.144 and Bauman.193 are meeting with Dr. Shivers this week and will hopefully be inviting her to speak at a meeting this spring.
- 1.4. There has not been much movement on the Buckeye Village issue since our last meeting when protestors attended to address President Drake. The CGS task force will be meeting with BV residents and members of the community to continue to push forward and make voices heard.
- 1.5. There is a grad/prof welcome back event on Thursday, January 9th between 4 and 7pm. Anyone who is free is welcome to attend and represent CGS.
- 1.6. The ombudsperson resolution is going forward to the steering committee after meeting with GCBC. There will be an update presented to delegates at the next meeting about this.
- 1.7. The tentative stipend increase recommendations are in the works. These new numbers will need to be discussed with Dean Bertone and Provost McPheron.

2. Vice President's Report

- 2.1. Officer elections will be happening at our March meeting and Senator elections the month after. Applications will be opened January 10th.
- 2.2. Delegate applications will begin to be accepted starting in March. Advertise these open seats to those who may be interested as word-of-mouth is the best way to get people involved.
- 2.3. Hayes Forum abstracts are still in the process of being judged.
- 2.4. There will be an Org & Elections meeting to discuss the process of senate elections.

meeting because the election process takes two meetings.

- 3.1. We have spent \$103K so far this year, which is less than 50% of our yearly budget so we need to be mindful to make sure we spend all of our budgeted money by the end of the fiscal year. The main reason we are under our target is because we are spending much less on food for delegate meetings.
