1. CALL TO ORDER

Bowers.461 called the meeting to order at 3:34 PM

Fitze.1 Raise your hand if you intend to be in Columbus this summer

Fitze.1 Want to talk about Officer elections; elected secretary had to decline position due to life commitment; opening secretary elections which will be held in May.

Patterson.694 I nominate Anneliese Antonucci

Antonucci.21 I accept

Fitze.1 Election period for delegates has opened – see e-mail that I sent this morning

Fitze.1 From here we will proceed for Senate. We have 3 open seats – Biological Sciences, Business, and Social and Behavioral Sciences . Open floor for nominations.

MacMaster.6 I nominate myself for the Business seat – from John Glenn College.

Gambrel.15 Can people switch from one seat to another?

Bowers.461 As the VP said, the committee has decided this year that we are going to try to recruit people from the relevant areas. If seats remain open in the floor, may broaden the pool.

Fitze.1 Any other nominations? None, have to approve to put Nate MacMaster for the Business seat.

Fitze.1 Approved, second, no discussion, Nate added, nomination period closed.

Fitze.1 Hear from uncontested candidates – each will give a 5-minute speech, we will then have a Q&A, and then move into executive session. Now – Janet Schroeder for Arts seat.

Schroeder 3rd year in Dance studies; finishing 3rd year as delegate. Take my role as representative of Dance department very serious. Started to find my voice more, look forward to bringing my voice to the Senate.

Fitze.1 Business seat – Nate MacMaster

MacMaster.6 I am from Glenn College, not Fischer – but determined we are close. Current Senator for the Business school – I was a delegate this year and served as a Senator. One of the most active committees in the Senate – looked at energy management issues, online course changes, and student fees. I was co-chair of the Student Fee Review sub-committee – examined all student fees, looked at which ones were really necessary and which ones we required more information about – developing a process where colleges have to prove that they had collaboration with students to increase/introduce fees. I was able to advocate for students in this process. Looking for ways to serve the university; next year is my last at OSU.

Fitze.1 FAES Senate Seat – Andrea Patterson

Patterson.694 In my 4th year – PhD student, been involved in CGS since my 2nd year, was insecure about my leadership, especially in regards to this organized, as I stay involved, I have built confidence and developed meaningful relationships with people on campus. As SERC chair this year, I provided opportunities for students to be involved with faculty members and speakers on environmental issues. I've definitely created a lot of active programming and meaningful relationships. Especially coming from a hard sciences background, I try to advocate for students who are interested.

Fitze.1 Math and Physical sciences – Anneliese Antonucci

Antonucci.21 Second year student in Biophysics – finishing my first year of serving in CGS – Communications chair – working on a survey to find out the best ways for delegates to receive information. Also went to NAGPS meeting – work on visas, ways for graduate students to benefit from federal funding. Want to continue serving the community.

Fitze.1 Professional Bio Sciences – Michael Koenig

Koenig I work in lung cancer and look at therapies for specific mutations. I've gotten involved in various student groups in the College of Medicine – finished coordinating Research day, a big interest of mine is medical ethics – a lot of the committees on academic misconduct for example, are interesting to me. Very important to be ethical scientists – great opportunity for me to grow professionally and academically. Shouldn't have any time conflicts in the upcoming year.

Fitze.1 Move into question and answer session – any questions must be directed to all candidates; 2 minutes to answer each question

Fitze.1 No questions, please step outside

Fitze.1 Moving into executive session – any discussion about the candidates?

Fitze.1 All elected to senate seats. Now move into contested elections. Each candidate will have 5 minutes to address the delegate body; Q&A after candidates for each seat.

Fitze.1 Humanities seat – Chloe Tull

Tull. Second-year in History department; political and urban history; in terms of my experience, I have learned to create small-scale solutions. Have worked for ACLU and Planned Parenthood; have large range of advocacy experiences. I was Government relation committee chair my first year, and in addition, I had the opportunity to attend the summit and go to D.C. in the Spring. Haven't been as involved in CGS this last year, but served as SAGE vice chair – representing Ohio State. Recently returned from Washington D.C. where I met with party officials and discussed impact of policies on the Midwest. Look forward to serving you all, come to me with questions.

Fitze.1 Next up is Matthew Connolly

Connolly. I'm a fourth-year PhD student in English, studying in Victorian literature. Had my candidacy exam on Monday. Worked in Public Relations in NYC, before coming to OSU. Started own company with my cousin, always knew grad. school was for me. Met with David for coffee to discuss what job entailed, also made a point to reach out to Jonathan Holmes. Bring a humanities perspective to my role, for instance – some recent issues in the senate – proposal for Teaching & Learning Institute, things like the Comprehensive Energy Management plan and concerns about what happens to people, think my background in the humanities can help address concerns. Perfect attendance at CGS, try to be as clear as possible in discussing what happens at Senate and communicating it here. I was on the GCBC committee where we advocated for a raise for minimum stipend, working with Debanuj on Diversity & Inclusion committee. Very rewarding experience with student government.

Fitze.1 3rd we have Julie Dentzer.

Dentzer. Currently in 3rd year in History of Art department. I am from France and receive my Master's from Sorbonne. I specialized in American Art and have switched to a French artist for my dissertation. I am studying a very interdisciplinary artist; I have various relationships with different departments within the Humanities – both faculty and graduate students, as well as undergraduates. Think I can represent Humanities at the Senate very well. I am an international student, as such well-equipped to address international issues – but also domestic. Was involved in Humanities Association in France – very interested in getting involved in student government at Ohio State. CGS delegate this last year, and want to get even more involved. I enjoy being on committees this year – I like touching on

different issues. Interested in Student Affairs, believe research is what led me here, want to focus on access to research. Haven't been that vocal in CGS this past year, but really striving to be more involved and more active. I have met with VP Megan to discuss this and am aware of the time commitment, and the balance. Know that I can fulfill this engagement. Know the struggles of being a graduate student and also an international graduate student. Ensure the continuation of excellence at Ohio State. Would love to be part of it. Hope you will consider voting for me, and look forward to questions.

Fitze.1 4th candidate on roster – Maria Salvador – researching at U of Chicago. Has written a letter.

Fitze.1 I am a second-year student in Art department focusing on Spain and Japan. I am very passionate about government, important to surpass individualism that isolates us in grad. school, and interested in learning how the university works, to help fellow graduate students at Ohio State. To build a better place, interested in working with research committee and the GCBC committee – I would also like to learn as much about the opportunities available. I believe I could be a good senator because I am interested in people with different backgrounds, acted as liaison in contemporary art organization. 5 different universities – unique perspective on student life.

Fitze.1 I would ask all candidates to come back up here – delegates have 1 min to state question directed at all candidates; candidates have 2 min to respond

Patterson.694 If you don't get a senate position, how do you plan to remain involved?

Connolly Will be involved by running for a delegate position; have experience and understand how this room works; interested in different committees like Suicide prevention

Tull I plan on being involved in Government Affairs Committee. In addition I am up for nomination for departmental leadership organization. Additionally, I am involved in my department community.

Dentzer. Running uncontested for delegate seat for next year; want to continue being part of CGS, looking forward to being a bigger part

Fitze.1 Any other questions? Hearing none, ask candidates to leave room. If no objections, now call us into executive session. Any questions or comments?

Fitze.1 Kerry will collect votes.

Fitze.1 Results will be announced at the end of the meeting

Fitze.1 First candidate for Education & Human Ecology – William Dupont

Dupont 3rd-year in the exercise science department; we study exercise – my group studies resistance exercise. My background in student government – in Upstate NY – I was a student senator in college, and led several student committee. Went to UNC at Chapel Hill, I was on the undergraduate student senate, was a senator for two years, and then became speaker of the house. Advocated on behalf of students. Then I went to the University of Connecticut, there I was a graduate student senator. And then I came to OSU, as a PhD student, I was little overwhelmed, been working in the lab since I got here, put max effort into whatever I do, I would take my election seriously, love advocating for student, truly believe in student government as space for students to discuss and decide their fate. I am new to

the body, so I have some new energy and fresh ideas. I knew something was missing – service to students is something I really like to do. Have booked out Thursday afternoons – shouldn't have any time conflicts. Understand what is required of a senator.

Fitze.1 Marcos Rivera

Rivera. Finishing up my first year as a senator; came to the university as a professional in Higher Ed; worked really closely with student government officials; made sure to hit the ground running, started in August, came in, elected at meeting, work hard to advocate from graduate students – served on GCBC – currently am on Provost committee to represent both graduate and professional students. Have helped out whenever it's been needed – try to jump in as much as I can. Made a serious effort to come not only to Senate meetings but also delegate meetings. So that I can hear what people have to say, so that I can represent you appropriately at Senate meetings. Continuing on GCBC, I want to make sure we get minimum stipend passed, but push further. Secondly, I have the ability to connect with the new provost, and make sure they understand the importance of graduate students – our voice is heard.

Fitze.1 Please come up – moving into Q&A – open the floor

MacMaster.6 What kind of committees would you really be interested in serving as a senator?

Dupont Definitely the fiscal committee – figure out what we want to do with student fees.

Rivera I mentioned GCBC – also have interest in serving in Student affairs committee – taking experience from my previous professional roles

Puthawala.1 Should you not be elected to serve in the university senate, how would you apply yourself?

Rivera. Been in conversation with David – hopefully jump in on a committee as much as possible

Dupont Running for a delegate seat; hopefully get elected to that

Holowacz.1 Are you able to make the senate meeting times?

Dupont Yes

Rivera Yes

Fitze.1 Any more questions? Please step out.

Fitze.1 Final election – Engineering Sciences. First speaking, Joachim Bean.

Bean First year in City & Regional planning; graduated from OSU a year or so ago – Bachelor of Fine Arts; as an undergraduate, I was involved in USG – committee on physical environment – Comprehensive Energy Management Plan – asking the hard questions about it, what caught my eyes was what's going to happen employees and benefits; never got a straight answer; concerning to me. Question of whether university is acting on best interests of students – would raise the hard questions to administrators if I were elected. Couple of things I worked on as a graduate student – leaders in College of Engineering; taking second look at our internship program – funding – also interested in increasing interdisciplinary work, have worked within multiple departments within university. Want to make sure university continues providing resources to support this work.

Wesaw. One thing I have learned from the work I have done outside of OSU with my tribal government; always ask everyone's permission before you present or take up their time. Is it OK for me to use up your time to present? Will be a 3rd-year PhD Student in City & Regional planning. Currently serve as a senator, serve on committee on physical environment, GCBC – lots of voices from community that have expressed concerns about Comprehensive Energy Plan. University has committed to making sure employees can work at another position at the university, and receive same compensation and benefits as they do currently. University committing to not moving forward on RFP process until Fall. Serve on U.A.C – appointment has to be approved by City of Columbus – great way of connecting with city community. Serve on Senate Advisory committee. Thank Joachim for running too – each senate seat should be a contested election. Great that we have this much participation.

Fitze.1 Moving into Q&A

Philipps.11 How will you balance all your responsibilities?

Bean Have taken the commitment into account, making a plan, structuring the schedule; just planning.

Wesaw While I'm doing these service roles, I am still in classes. Will have more times after candidacy. Make an effort to consciously plan where my time is spent, given where meetings fall, all works out.

Fitze.1 Hearing no more questions, opening executive session.

Fitze.1 Run-off for Humanities seat –Chloe Tull & Maria Salvador; opening up the discussion

Fitze.1 Concludes elections

Bowers.461 Thanks to everyone still in the room and anyone who ran for Senate who is still in the room. Thanks to all of you and the organization elections committee, particularly Megan in her role as VP. Opportunity to recognize some people with annual awards.

6. CGS Annual Awards

6.1. James M. Siddens Award for Distinguished Faculty Advising In 2002, upon the retirement of James M. Siddens—the CGS faculty advisor for nearly twenty years—the Council created the James M. Siddens Award for Distinguished Faculty Advising to recognize those faculty who exemplify the best in graduate student advising at Ohio State. The only award of its kind on campus, this award is given annually each spring to a member of the graduate faculty.

Bowers.461 Author of several books on language, literacy and role of place and race. Dr. K – College of Human Ecology – holds multiple positions, advocates for graduate students' funding and other support, serves as a mentor, helped initiate multiple committee throughout college, committed to diversity and equity. Dr. Valerie K.

6.2. Colin Odden Award for Exceptional Service as a CGS Delegate In 2016 this award was named in honor of long serving CGS member Colin Odden. This award honors a Delegate who has made a significant contribution to CGS and graduate students in the past year.

Bowers.461 Colin can't be here today – sent a lengthy e-mail thanking us and the body, and remarking how important CGS has been for him.

Bowers.461 Winner is somebody you have heard from a little already – Janet Schroeder. Dutiful delegate who has served with CGS representing department of dance, made a concerted effort to involve graduate students in the arts, does a great job of communicating regularly with executives, letting them know when they've done things well, and when they could improve. Because of Janet's advocacy that we still have an Arts & Culture committee.

6.3. Committee Chair Award for Excellence This award honors a Committee Chair who has shown significant progress and commitment to ideas and the graduate student experience through their service to CGS and graduate students.

Bowers.461 Committee ended up voting for 2 people – first is the chair of SERC, Andrea Patterson. The nominator wrote that Andrea has done incredible work with SERC, collaborating with forces across the university to create events, has managed one of the most popular committees with efficiency professionalism. Completed her duties with care.

Bowers.461 Last winner – Debanuj DasGupta; wrote that Debanuj has worked tirelessly to promote diversity and inclusion; organized first Implicit bias and diversity training; serves as a graduate student liaison; has organized events that support women artists, LGBTQ activists, and involved in TedX. Great asset to our campus. Great asset to our campus.

Bowers.461 Thanks to everyone for your work.

7. OLD BUSINESS

7.1. Ad hoc Committee on CEMP status update.

Bowers.461 Committee has been formed; Hoda has agreed to serve as our chair; everyone who expressed an interested in serving was able to be appointed – organizing first committee meeting, has already met with Andrea, SERC committee chair, and Sam Reed, who has been active throughout the year.

Bowers.461 University has announced that the next stage – not happening until the Fall – administration has slowed the process so that the next phase will not happen until we are all back; appreciate that this has happened; concern about displacement of workers – commit to keeping staff members who wish to remain employees of the university, with same level of pay and benefits. Doesn't answer all concerns, but it is a nice update.

8. NEW BUSINESS

8.1. Any Delegate Issues and Concerns

Bowers.461 Appropriate use of graduate student labor – particular teaching assistant labor; class sizes that people are expected to handle as instructors of record with/without other assistants; ongoing concern – earlier this year we were able to work constructively with administration; seem to be coming up with a number of departments – difficult year to directly confront some of those because we have an interim dean and provost. If this has been a concern for you and if you know of any listed

expectations for size of class GTA takes with/without any assistance, please e-mail me this information – would like us to be able to document this information.

Bowers.461 There are GTAs in one department who have raised issue of safety – feeling threatened by undergraduates in classroom setting. Issue dealt with term in which it occurs (in this department) but no way of tracking where graduate students stand in terms of knowing what might be facing them in their classrooms.

Ethier.4 Was it threatening as in physical harm...? How serious?

Eisenman It was my department, and was physically threatening. Might have an issue with PTSD – no system in place to warn people who might work with him next semester. Also a privacy issue for student. But student has been disruptive, and person who brought up this issue did feel threatened.

Bowers.461 Privacy issues of all kind, but if you know of something in your department, just let me know by e-mail – would like to know about them. Important to air them as concerns that graduate students are facing.

Dentzer.3 Was going to bring up exactly this topic – sounds very similar to issue in my department. Student brought it up to department chair – no one seems to know what to do, surprising to us that there is no entity – issue was between two students but TA didn't know how to handle it. Current issue.

Alex.25 Has anybody talked to SLDS – Disability services would need to be looped in?

Bowers.461 Pathways to explore on this; interested in how much of a discomfort/concern it is

DasGupta.18 I think it happens – has been discussed in my department; happens to us on a regular basis, given what we teach (race, Islamophobia, etc) – have had some conversations on how to deal with problematic students – workshop on how to deal with disruptive students. Emergency health issues – some protocol about. Would be very helpful to have the conversation at a systematic level. It's a regular feature – don't know what OSU's gun policy is – is a national concern.

Gambrel.15 Worth mentioning that the Code of Student Conduct mentions creating reasonable fear; can be reprimanded for that. That is an avenue.

Puthawala.1 Second recommendation to have a systematic conversation; an integral part of our training was what we could do to handle this type of situation if it arose; I've heard nothing about this type of treatment except for referring back to department chair. I wouldn't know who to talk to.

Hollowacz.1 In further support of points made, when I took the UCAT teaching orientation – I remember a lot about being careful about accusations of plagiarism, but don't remember anything about what to do if one feels threatened. Protect as many people as possible. Surprised student didn't have hearing with the conduct board.

Patterson.694 Conduct Board keeps records of student – develop way to rehabilitate student if need be – avenue to establish with UCAT

Wirza.1 Have you noticed stickers on some tables in classrooms which include an emergency number? How is that number being used? Maybe make sure all rooms have the sticker – maybe make it more obvious/larger.

Don't know what the formalities are, but might be good idea to give heads up.

Alex.25 First question about class size – wanted to point out we talked about tracking hours – 28 students – grading 10-page compositions – might be more work than a 100-student class with less grading. When is reasonable amount of time for GTAs to know what they're going to be teaching? Could have missed, can't find anything in handbook. E-mail me if you have any information.

Bowers.461 This is an issue that we can address from quality of undergraduate education perspective.

Eisenman Changed format when class sized increase; not just about our hours but also about quality of education

9.1. May Meeting May 27,2016 3:30 PM Ohio Union

Happy new academic year and new term for CGS officers! I am excited to be at the opening moments of a second term as your president. As you'll note in the Vice President's report, we're coming off a remarkably successful spring delegate election, with 70 seats filled. This puts us in good position to achieve our goal of filling at least 100 seats by our Fall election. The Spring delegate election response, combined with our successful Senate elections last month, suggest that our efforts to encourage greater participation in CGS are beginning to bear fruit.

As I promised in last month's update, what follows is a reflection on some of our achievements as a body over the past year. Please note that all of these achievements resulted from team efforts—our delegates, officers, committee chairs and committee members made this list possible!

- Working with Administration & Planning, as well as Office of International Affairs, we have established a parking lot for students to practice for the Ohio drivers license
- We created an Implicit Bias and Diversity training program for Grad/professional students and postdocs. We reached across university to capitalize on expertise in ODI and MCC, customizing the presentations for the targeted audience. Our primary was to engage 60 students, but in the first 2 days we received nearly 250 signups. More than 130 completed the 3 session certificate program.
- In April, we also had the 1st Symposium on Diversity in the Academic Workplace, with Chief Diversity Officers from Grinnell and Harvard. More than 120 people

attended the morning panel discussion and Luncheon program on Mentoring across cultures.

- In the Fall we held the first annual reception honoring Ray Travel Award winners and their advisors. This event provided a way to showcase the research of some of those whose work we further through the Ray Award program, giving all of us an opportunity to glimpse some of the work graduate students are presenting at conferences around the world.
- We gained graduate student representation on the Provost Advisory Committee in their work searching for candidates for our new Provost.
- This year's 30th Anniversary Hayes Forum nearly doubled its applicant pool to approx. 430 from just over 250 last year. 143 students presented their research.
- Expanding opportunities for important decision makers in the University to meet with Graduate students:
 - Partnered with the Board Office initiate Informal student chats with Trustees,
 - Hosted Focus Group on how Institute for Teaching & Learning can help GTAs
 - Held series of CGS Senator dinners with University leaders
 - University Leadership addressing CGS Delegate body in 2015-16
 - Grad School Dean Osmer

- Provost Steinmetz
- President Drake
- We led efforts on Council on Student Affairs to achieve easier transparency regarding uses of the Student Activity Fee for all students. We successfully resisted some attempts to further reduce funds allocated towards student governments.
- Internal:
 - We made intentional efforts at community building within CGS
 - Increased number of orientation sessions
 - Informal gatherings for new delegates and officers—get to know someone before walking into the Senate Chambers
 - We held monthly meetings for senators
 - Regular meetings for officers
 - Transparency and accountability
 - Published meeting attendance sheets
 - Incorporated reading part of CGS Code of Ethics @ each meeting
 - Bringing practices and procedures in line with one another.
 - Increased visibility
 - Huge effort in the Fall to reach into various schools and programs that did not have CGS representation. Similar effort this Spring—
 - Achieved our Spring election goal of doubling the amount of candidates we had last spring.

Of course a major concern for which we have not yet received a definitive answer is the administration's response to GCBC's report and recommendations regarding GA stipends. CGS endorsed this report and we were able to present it to a variety of bodies including: Grad Council, Senate Steering and Faculty Cabinet. Both President Drake and interim Provost McPherson have expressed committed support for the recommendations made in the report, but have not yet been able to report progress in meeting them. I remain hopeful that we won't see another year of stagnation in minimum stipends come Fall.

As we now turn our attention to the year ahead, I believe that we are well positioned to continue progress in the various areas noted above as well as further increasing CGS ties with the life of the university through a new speaker series, greater collaboration with the other two student governments and continued participation and presence on the many committees on which graduate students serve.

As always, thank you for allowing me to serve as your president.

Vice President Report

- We have officially transitioned from Megan Fitze to myself as of 5/9/2016. I am grateful for all the hard work Megan has put in to help the transition run smoothly. Also, thank you to the executive committee and delegates for your patience during the transition.
- We have 5 applicants for secretary. We will host elections for the position.
- We will begin committee assignments in the next couple weeks. Our Chief of Staff, Zak Foste and, President, David Bowers will be helping with this process. We will be using the survey that was sent out regarding your preferences for committee assignments.
- As I am new and haven't met most of you, I would like to schedule something formal to meet with you. But for now, please don't hesitate to reach out if you would like to set-up a formal or informal meeting.
- The delegate nominations have been completed for Fall. Below are the numbers for each:
 - Overall Nominations: 233
 - Delegates elected (seats filled): 75
 - New representatives from seats from Departments not previously filled: 12
 - Overall Individual Departments represented: 63

WHEREAS The Council of Graduate Students (CGS) is the representative body of all graduate students enrolled in The Ohio State University (established by Article II.I of the CGS Constitution); and

WHEREAS the current service expectations for delegates require service on both one CGS committee and one University-wide committee;

WHEREAS all graduate students in good standing are eligible to be considered for appointment to both CGS and University-wide committees;

THEREFORE LET IT BE RESOLVED that Section I.11, Roles and Responsibilities of Delegates, of the CGS Bylaws be amended in the following three ways:

2. Delegates must sit on at least one of the CGS or University Committees (the Vice President maintains an ongoing list of both internal CGS and University Committees); ~~or those committees originated and maintained by the Council of Graduate Students;~~

3. Delegates may be appointed to additional committees based on their availability; ~~must sit on at least one external University Committee (the Vice President maintains an ongoing list of the University Committees or those committees not originated by the Council of Graduate Students),~~
