1. CALL TO ORDER: Meeting called to order at 3:35pm

1.1. Statement of Purpose

- 1.1.1. To effectively advocate and program to ensure that The Ohio State University graduate student experience is the best it can be.**

2. APPROVAL OF MINUTES

2.1. Minutes from -March 29, 2019

- 2.1.1.** Wiegman.3 motioned to approve the minutes.
2.1.2. Loria.3 seconded the motion.
2.1.3. Minutes approved.

3. SPECIAL ORDER ITEMS

3.1. Delegate Concerns

- 3.1.1.** Estiri.1 is chairing the International Student Concerns committee. Last week an international student approached them who is having issues with his CPT application approval. This is a university approval to work over the summer. Ehsan reviewed this student's application. He felt that the Office of International Affairs (IOA) rejected this application without reason. This is something he will be working on in his committee, but he would like the support of other committees as well: Graduate Affairs, Diversity, etc. Also, Ehsan recently represented this body in the SAGE event. SAGE is an advocacy group that advocates for graduate students.
- 3.1.2.** Givans.2 wonders if there is any follow-up from the charge that Kristyn speak to the parking committee about our concerns. He should reach out to her if it is not in the report. These concerns were with graduate students with lab work being displaced during the weekends because of game day parking.

4. GRADUATE SCHOOL UPDATE

- 4.1. Last year, they brought their thoughts to this group regarding what to advocate for next. They did this with graduate chairs, faculty, and program coordinators. Last year, a delegate mentioned an ombudsperson. They are now looking into this. They have implemented a new handbook which addresses these past concerns. Dr. Alicia Bertone, Dean of the Graduate School, would like to open up the topic of student advisor relationships.
- 4.2. This presents issues such as advisor approval required course enrollment. Graduate students are overworked in the lab, etc. They have been looking at best practices. First, there is no standard mechanism by which students evaluate their programs. The goal is to create a mechanism for anonymous annual feedback. An annual progress report will be included in Workday. Curricular plans would also be signed off on by both parties. Another change would be how advisors evaluate students. One edge of the scale will be “needs regular and consistent support to accomplish work” and the other end will be independence. This will broaden primary skill sets. It is better to address issues earlier.
- 4.3. Wiegman.³ states that the reporting sounds like a good idea but wonders what is next. It might be difficult to get faculty to implement these changes. They are talking to CGS first and will talk to faculty next. Many already have a data management tool for students, but it is almost too much information. They hope to simplify their load.
- 4.4. Dentzer.³ thinks it is a good idea but that it might lead to some issues in smaller departments. Have they thought about retaliation? Also, a lot of issues arrive after candidacy. These follow-ups and evaluations continue every year. Retaliation is illegal, and they will be watching for any signs of that. We need to make sure that we have safe spaces for students to report serious problems.
- 4.5. Mandal.³² mentions that students might be deterred from negative reviews if they are not sure what happens to them in the case that their advisor is taken away from that position. They are hoping to open communication. It is the responsibility of the department and college to not leave students stranded without an advisor.
- 4.6. Shahhosseini.² asks what would be done to support international students. She knows people who have reached out but left the school due to issues with advisors. Advisors may suspect a certain student submitted a negative evaluation. International students would be the same as domestic, though they do understand that there are specific challenges. They are hoping this system will catch advisors who don't work well with international students right away.

5. COMMITTEE CHAIR UPDATES (as submitted in Delegate Meeting Packets)

- 5.1. Holt.³⁵¹, chair of Arts & Culture, mentions that they are hosting a paint night next week for graduate students.
- 5.2. Dentzer.³ represents DELIT. It is really important to have graduate students on this committee. They have been working with USG to create better collaboration with faculty regarding Carmen. The graduate student voice is important here. Also, DELIT has several awards. Perhaps there could be a graduate award. Please reach out to her for more information as she is stepping down.
- 5.3. Estiri.¹, chair of International Student Concerns, is putting forward a resolution today. They have been collaborating with Student Legal Services.

6. OFFICER UPDATES (as submitted in Delegate Meeting Packets)

- 6.1. Walterbusch.¹ asks that if you are not running again as a delegate, to ask someone else to apply by the end of the day to today.
- 6.2. Wesaw.¹ thanks the delegates for the privilege of serving as president.

7. NEW BUSINESS

7.1. Call for Officer Nominations & Officer Election (Treasurer)

- 7.1.1. DaVonti' Haynes.²⁴² is the only candidate and is elected as Treasurer.

7.2. Senate Elections

- 7.2.1. Walterbusch.¹ explains that the election process is a little bit different. There was a meet and greet so the senate candidates will not be speaking at the meeting today. We will pass out ballots and ask delegates to submit this to Kerry. Vote for as many as you would like. If there are any ties the President will choose.
- 7.2.2. The following Senators are elected: Richard Broshious, Ehsan Estiri, Coralie Farinas, Bethany Frick, David Hibler, Gala Korniyenko, Sara Mueller, Ryan Slechta, Blake Szkoda, Chris Wiegman.

7.3. Resolution 1819-SP-003: A Resolution Supporting Renewal of Contract Between Student Legal Services, Inc. and The Ohio State University with Expansion of Benefits to Include Immigration and Naturalization Services

- 7.3.1. Estiri.1 explains that Student Legal Services (SLS) does not currently provide immigration related services. They were really receptive to creating a division to provide these services. The International Student Concerns committee endorses the plan SLS has created to address this issue.
- 7.3.2. Adeeko.5 mentions that line 27 says there will not be an increase to student fees as long as the University concurs. She wonders if there is any possibility for this. SLS is not a part of the Ohio State University. They have agreed not to increase their fees and the University is on board.
- 7.3.3. Shah.1285 asks if they have talked to OIA? This is part of a larger set of bylaws. SLS is not going to challenge OSU entities.
- 7.3.4. Cao.847 asks for examples of the services that will be provided. They will start with family related issues and expand to other areas. Family reunification and visits would be a first step.
- 7.3.5. Slechta.3 asks what services does Ehsan envisions under further expansion. These would be services related to the naturalization processes. Many students are seeking ways to stay in the United States.
- 7.3.6. Wesaw.1 mentions that there are a few clean-ups such as the addition of the author's name.
- 7.3.7. Estiri.1 presents the other clerical edits.
- 7.3.8. Ziemann.2 motions to accept these edits.
- 7.3.9. Ingles.27 seconds
- 7.3.10. The motion passes.
- 7.3.11. Dahlberg-Sears.1 moves the previous question.
- 7.3.12. The resolution carries.

7.4. Resolution 1819-SP-004: A Resolution Affirming the Value of Graduate Work Space and Graduate Involvement in Decision-Making Processes

- 7.4.1. This resolution is coming from two delegates so we will need a second to consider the resolution.
- 7.4.2. Uanhoro.1 seconds
- 7.4.3. Dalglish.2 explains that this was prompted by the acquisition of graduate office space by the graduate school. Some funds have been set aside to refurbish current space in the effected department. The resolution does not call out which parties are responsible. It became clear that the exact party could not be determined. This also helps it to have broader appeal.
- 7.4.4. Pierce.508 has a question about how general this is. Are we sure that the specific parties involved will understand? It is unclear who approved this poor decision. If they are identified this will apply.
- 7.4.5. Estiri.1 is still confused about the problem. Graduate students in a department found out that the graduate school wanted to acquire their TA office and were not sure what to do. They attempted to reach out to those who made the decisions. This issue prompted them to write the resolution.
- 7.4.6. Wadhwa.21 wonders if they can call on a specific office or administrator for action in terms of consulting graduate students. Could the resolution call for action from a specific group to assist graduate students.
- 7.4.7. Pierce.508 feels this is generally a good resolution. He just wonders where the resolution is going after this. Will it be sent to anyone? It does make a note to strongly disapprove. This will direct the president to send this to the Graduate School.
- 7.4.8. Wiegman.3 also suggests sending it to the chair of the department. The chair seems to be on their side, in this case, and it trying to help.
- 7.4.9. Slechta.3 feels that the value of this policy is its generality.
- 7.4.10. Ziemann.2 calls the question
- 7.4.11. The resolution passes

7.5. New Business

- 7.5.1. The count of those that said they would be able to attend summer meetings was 34.

Parking Advisory Committee (PAC)

As I announced in the February Delegate Meeting copied from the email I received back:

The parking spaces around the stadium are reserved earlier in the week to accommodate large media vehicles / semis that need to arrive in advance to set-up for the Saturday home games. Since permit holders are not guaranteed a specific space, but instead, access to a parking space within their permit classification, alternate parking options are still available. For example, during the week, a B permit can park in other B and C parking spaces on central campus and on west campus. For football Saturdays, alternate options are also available. Here's a link to last year's football map - <https://osu.campusparc.com/docs/default-source/maps/football-parking-map.pdf>. Annual permit holders can park in any day-of-game parking lot at no charge as long as they display their event hangtag.

Although I doubt this policy will change, I encourage the next delegate to sit on PAC to continue this line of questioning.

Office of Distance Education and e-Learning (ODEE) Steering Committee

ODEE is working with Unizin to reduce textbook costs with a program called CarmenBooks. Text books will cost around \$35 (~77% less than paper) and will be made available by the first day of classes on Carmen for more classes starting in Autumn 2019 semester. College of Social Work will be fully on this for available books. For instructors to sign-up Carmenbooks@osu.edu and CarmenBooks link on affordablelearning.osu.edu website.

ALX program – partnership between ODEE, University Libraries, USG, and institute for teaching and learning. To help save students on course materials. Started as a grants program. Convert expensive course materials to affordable. Saved students \$5.5mil (~20,000 students) spring 2020 \$8.5mil, and 10mil goal by autumn 2020. Content Camp faculty development camp around text banks and assessment offerings. Website building to facilitate this work that is a partnership with Penn State. Collaborative Authoring model to establish list of shared topics for a course and write ~100 questions each as a team. Come out with ~1,000 questions openly licensed and available to users of a site for a course. Tool allows for peer feedback to improve quality of content better than what is available from published. Fall content camp coming. Open to any disciplines.

ODEE Professional Learning (replacement term for professional development). Used to be focused on disparate workshops and webinars with decentralized staff and content. Current goals are to be more aligned with teaching and learning initiatives and are evaluating existing content and opportunities. Developing hybrid, online and in person programming, streamlined technology training, and a robust recourse center (“toolset” topics and teaching topics) www.edsurge.com/news/2016-10-06-a-step-by-step-guide-to-untethered-faculty-development

Budget model rebasing still remains unfinished but is expected to be completed by the end of May. Plant Operations and Management (POM) fee rates paid by the colleges were recommended by the CFS subcommittee and approved by Senate Fiscal for recommendation. Facilities Operations and Development had requested an increase in rates to help pay for campus expansion projects as well as energy saving measures, including a new combined cycle power plant. While CFS felt that these were worthwhile initiatives, the consensus was that the POM rate was not an appropriate mechanism to fund them, and would represent a major burden on the colleges that could jeopardize their core academic mission.


