## 3. Krista Predagovich from Office of Student Life—RUOKBUCKEYE Suicide Prevention

Bowers.461 introduced guest – also graduate student - Predagovich –  $4^{th}$  year working with suicide prevention How we view suicide / people at risk; what about people who are not on brink? Getting away from the word "commit" – associations with crime/sin; 1 who dies from suicide – 45 attempts – 250 seriously consider.

How to care for/reach the 250?

- Being an advocate for the RUOKBUCKEYE initiative within your academic unit survey within academic units – 30 have participated. Let grad studies chair know about this, ask staff member to send out survey – anonymous confidential survey. People who fill out survey will get a personalized response and directed towards available resources on campus. May result in changes in curriculum and program.
- 2) Pass out flyers give to faculty or staff member who cares about student experience
- 3) Suicide Prevention Gatekeeper Training program pay attention; be aware of warning signs in friends, colleagues, TAs; how to reach out and show concern; which resources can I connect them to? Developed by faculty. Any university that receives state funding must provide basic suicide prevention training senate bill.
- 4) Over 200 trained. Goal is to train 5000. As a result certificate + scarlet & grey awareness pin
- 5) Questions:

Wirza.1 How far ahead should an application for training be sent?

At least 2 weeks in advance.

Are there any training programs that are already scheduled?

Open training to anyone on campus or community groups - advertised on website

Eisenman.1 How is it different from UCAT suicide training?

It is the same.

Do you report back on general wellness of students from survey?

8% response rate – generally OK, average; but with higher response rates, sometimes more concern

Puthawala.1 Anonymous AND there is feedback sent to department? Sometimes distrust between grad. students and department administration. Will my status be endangered if I admit I'm depressed? How do we reassure people?

Invitation letter will address some of these questions; the platform is American Foundation for Suicide Preventions; username & password, e-mail encrypted, available for both anonymous and one-on-one conversations without revealing any personal details

Grad Program Coordinator - 30 - filter what you're sharing - only general comments

Academic programs - what if there are several high-risk students and don't know who they are? Linked to resources; only disclosure if extremely high risk (brink) - ethical and professional obligation
