## OFFICER WRITTEN REPORTS

Current as of September 18<sup>th</sup> 2015, 10:00 PM

### President, David Bowers.461

- The Fall term is off to a busy start. Internally, I am pleased to report that now all committees are Chaired with the exception of Health and Wellness. I do have one additional prospect to lead that committee, but if any delegate knows of someone, or has a personal interest, in possibly leading this committee, please let me know!
- We've made progress on 3 of my top new initiative priorities:
  - A Diversity/Implicit Bias Awareness certificate program for graduate students. The Diversity and Inclusion Committee is moving forward on programming this effort. I've had very positive response from across the university, including President Drake, Provost Steinmetz and Dean Herness.
  - Receptions featuring recent Ray Awardees and their advisors. Tori Negash is leading the organizing on this effort. These events will allow a broader cross section of graduate students and faculty to learn of the exciting research our fellow students are presenting around the country and throughout the world.
  - A CGS Co-sponsored speaker series in which we partner with a college or program to bring in a "star" in that field, and feature both OSU faculty and graduate students in the same event. The Provost has agreed to underwrite the initial effort. Details will be forthcoming.
- Other Major Areas of Focus:
  - Graduate Min. Stipends. The university administration appears committed to this as an issue for the year. I am hopeful that we'll see an increase for the first time in a couple of years.
  - Grad School transition/Dean Search: Interim Dean Herness, Assistant Deans Wallace and Salimbene are being very helpful to me as questions or concerns arise. The Grad School will be undergoing an internal study/review as part of the process for a Dean search and CGS will be involved in that study, as well as the eventual search.
  - Insurance: The university administration continues to work with federal officials to find a remedy to the potential problems featured in the media regarding student health plans and funded graduate students. Fallout from recent change in Student Health Plan: since the last delegate meeting I have been collecting accounts from graduate students of challenges they've faced. Thus far the change in drug formulary seems to be the largest issue. Administrators are very receptive to hearing about problems grad students have encountered and are looking into both whether there are ways to remedy current challenges and/or how to ensure fewer unpleasant surprises the next time the plan changes providers.
  - National student advocacy groups: CGS is a founding member of two organizations: National Association of Graduate and Professional Students, and Students Advocates for Graduate Education. Currently we have the National vice-chair of SAGE, Chloe Tull, and Regional Legislative coordinator for NAGPS, Brandon Creegan. This is the first time in recent memory that OSU has had representation in leadership of both organizations.
  - We will have Provost Steinmetz as our guest at the October Delegate meeting. I look forward to hearing from him and hope that you'll prepare any questions you might have about the myriad aspects of the university's life that come within his area of responsibility.
  - Finally, at our September meeting we will open the meeting with the Vice President reading a portion of the CGS Code of Ethics in addition to our Statement of Purpose. The full text is included in this packet. I hope that by featuring a portion of the Code each month we might all remember our mutually held values and responsibilities.

## Megan Fitze.1, Vice President

### Election Updates:

- By the time you read this, delegate elections will have ended on September 16th, and we should have new delegates at the upcoming meeting on September 25th. During the election period, we had about 38 students run. At this time, I cannot say how many new students will be elected, but I will be able to provide that number at the meeting.
- For departments that do not have have their delegate seats filled post-election, I will be putting together a "petition package" for students explaining ways in which students can officially petition to fill a seat. This will be available on the CGS website for students to access in the next few weeks.
- I would like to thank the executive staff that their aid in helping me recruit these past few weeks. It has been a lot of work and your help has been amazing.

### Committee Updates

- Delegates that are not newly elected should have been assigned and notified of their committees. Please contact me or Zak if you have had any issues with your committee assignments or still do not know which committees you are serving on.
- Internal and external committee assignments should all be up on the CGS website. If you see an error on the website, please let me know.

## Secretary, Guyomar Pillai.30

- Attended first Graduate Council meeting on September 14<sup>th</sup>. Here are some updates:
  - A Curriculum Committee is currently being formed. Its responsibilities are to review proposals from programs for curricular or name changes, or for the creation of new master's or Ph.D. degrees or interdisciplinary specializations.
  - Previously, review process involved two subcommittees – Grad Council & Council on Academic affairs; being combined into a single subcommittee
  - The committee will consist of six faculty members and two graduate students (nominated by CGS)
  - The Council on Academic Affairs is reviewing the possibility of expanding certificate programs at Ohio State; these would allow students admitted to the graduate school but not enrolled in a particular program to earn certificates (12-20 credit hours). There is only one certificate program at Ohio State currently (offered the Center of Medieval and Renaissance studies) and a subcommittee will be looking at certificate program requirements at peer institutions before our October meeting.
  - The *Graduate School Handbook* has been updated for Autumn 2015 and is available on the grad school website; more updates will be made as changes to May/Summer term sessions are underway and there may be four different sets of deadlines associated with courses during these terms.
- **OUAB** has partnered with UCAT to offer several professional development workshops on the academic job search. These are typically held Mondays, 2:30-4:00 PM. One upcoming workshop is on "Teaching and Research Statements" on September 28<sup>th</sup>. Find more information and register for this workshop here:

**What?** The GGG awards **up to \$1,500** to applicants from across the university, traveling to a variety of countries, with special consideration for those in which Ohio State has a Global Gateway office (China, India, and Brazil) and in which it hopes to open an office soon (Ethiopia and Turkey).

**How?** Applicants must plan to apply their research to completing their thesis or dissertation, and to bolster relations between OSU and universities and other institutions across the world. This research must be independent of other activities, such as study abroad.

## **Guyomar Pillai.30, International Concerns**

I met with the previous chair of the committee, Roger Anderson.2299 on Tuesday, September 8<sup>th</sup> 2015 to hear about the work previously done by the committee and ongoing issues for the international population. Among points we discussed, of note were:

- o International student **safety** as an ongoing concern, especially when it comes to reporting of crimes related to harassment and rape
- o **Driving issues**; orientation materials provided to international students still do not make it clear that an Ohio driver's license is required to drive legally in this state. There is also a lack of safe areas where students can practice driving as they are not allowed to use university parking lots due to liability issues. This makes it more difficult to obtain a license as no alternative has been provided, and significantly impacts the living conditions of international students as they have even more limited housing options without the convenience of a car.
- o **Representation on USG**; while this does not affect graduate students directly, there is no committee representing international students on USG. Since our work involves advocating for international students, we may speak to USG's Diversity & Inclusion chair to ask why there is no specific committee addressing issues that affect this population (for example, an international student fee that almost doubled this Fall). Our hope is that there will be better representation and advocacy for all international students, and that we can coordinate our efforts with those of USG.

Our first committee meeting was held on **September 15<sup>th</sup>**. Yanty Wirza.1, Marissa Stewart.921 and I agreed to:

- o Design and disseminate a survey to gather information about major concerns and needs of the international student population; we would like to know about recurring issues that affect a significant portion of international graduate students. We plan to work with the Office of International Affairs, the Multicultural Center, and the Graduate School to reach as many students as possible. We plan to send out the survey in October after more discussion and preparation at our next committee meeting on 10/13.
- o Host a Fall social event in November to establish our presence as a committee and also provide an informal space for international student to share some of their concerns.
- o Host other events/workshops in the Spring so we have ample time to plan for these. The nature of these events will be dependent on our survey results as we hope to address the core issues affecting the international community.

## **Andrea Patterson.694, SERC**

SERC - haven't met with the delegates assigned yet. They will be hearing from me soon. Currently I am talking with Tony Gillund of Energy & Sustainability Management at OSU, meeting with him next week to see where we can help them push some of their initiatives forward/ provide feedback. I have also reached out to USG, since they are usually very zealous with their initiatives. I am hoping to identify some things we could help push on the CGS end - in the interests of graduate students and where we can help. Once I have done this I will call a meeting with my delegates and identify with them how we can move forward and their goals for this year in SERC. Those looking for a volunteer opportunity: Energy & Sustainability Management at OSU runs the Zero Waste Program at the OSU Stadium for football games and they are looking for volunteers. I have done it and it was fun, the tailgaters are usually receptive and will even offer some of their tailgating goods! (1) They want LOTS of volunteers - so if you can get a group together that would be great! (2) they are looking for feedback on how to improve the program because it needs work. - The north end of the university district has experienced frequent power outages, some of which have been quite lengthy. UAC is in discussion with representatives from American Electric Power and City of Columbus' Department of Public Utilities. A public hearing is sought but not yet planned. In the meantime, please report any electric service disruptions to [odden.2@osu.edu](mailto:odden.2@osu.edu), who will share them with Code and Environment committee Chair Tom Wildman.

- UAC will work with OSU Campus Ambassadors toward bridging the student-community gap in neighborhoods around the university.

This group has to date been very undergraduate-focused, but this has be de facto rather than by design. UAC's Community Relations committee will meet with representatives from Campus Ambassadors at its October meeting (8pm October 7, Rm 100 Northwood High Building). - The Columbus Board of Education has appointed an ad hoc committee to discuss district demographics and neighborhood schools. The placement of schools not only affects graduate students with school-age children, but students in educational programs seeking professional practicum experiences such as student teaching. University Area Commission's Ad Hoc Education committee will attend closely to district discussion on apportionment and schools including those in the neighborhoods near the university. ## **Article XIII - Code of Ethics and Values**

*(This code is based on the work of the Santa Clara University's Associated Student Government and the Markkula Center for Applied Ethics) (Approved 4/18/14, 1314SP014)*

### **Preamble**

The Council of Graduate Students of Ohio State University (CGS), hereinafter referred to as CGS and the Organization, is the official body representing graduate students' diverse issues, concerns, and needs at Ohio State University. We involve students in a productive partnership in governance of the University, promote the internal welfare and unity of the student community, further the goals of our University, and respond to the challenges of our society. To these ends, CGS has adopted this Code of Ethics and Values (hereinafter referred to as our Code) to (1) live out the mission espoused in our Constitution; (2) and establish basic standards of ethical behavior for academic and professional life. A CGS representative is defined as any member of CGS acting in any capacity for the organization, including: Officers, Committee Chairs, Committee Members, Senators, Delegates, and appointed members. Every CGS representative is a signatory to the Code, which symbolizes a united pledge to abide by the Code's spirit and principles. The ten values enumerated in this Code represent ten equally-significant guiding ideals of the Organization, and delegates hold themselves and each other accountable for adherence.

### **Behavioral Standards and Values**

#### **1. As a CGS Representative, I value *Honesty*. In practice, this value looks like:**

1. I express my genuine opinion on issues even if my view is unpopular.
2. I only make promises that I genuinely believe I can keep.
3. I disclose my affiliations with any organization or with any friends or groups that have substantial business with CGS.
4. I abstain or recuse myself from the decision-making process in all situations when I believe that I cannot exercise impartial judgment.

#### **2. As a CGS Representative, I value *Fairness*. In practice, this value looks like:**

1. I seek out diverse ideas/opinions and reserve judgment until I have all of the relevant information.
2. I treat all viewpoints with respect, even if I do not personally agree with them.
3. I only take credit for work that I have done and acknowledge everyone who assists me in accomplishing tasks.
4. I observe the established procedures detailed in the Constitution and Bylaws and demonstrate transparency in my decision-making process.

#### **3. As a CGS Representative, I value *Flexibility*. In practice, this value looks like:**

1. I am willing to re-evaluate a prior decision in light of unforeseen circumstances in order to uphold the fundamental mission of CGS.
2. I adapt my communication style to the situation, and to accommodate the concerns of persons involved.

## **Article XIII - Code of Ethics and Values**

### **4. As a CGS Representative, I value *Responsibility*. In practice, this value looks like:**

1. I seek to maintain personal integrity and the integrity of the organization.
2. I can clearly articulate how my decision will advance the Organization's core values.
3. I use CGS materials and resources solely for CGS-related activities.
4. I take ownership for the decisions I make or fail to make, the actions I take or fail to take, and the consequences that result.
5. I protect confidential information that has been entrusted to me.

### **5. As a CGS Representative, I value *Communication*. In practice, this value looks like:**

1. I clearly convey messages and relay necessary information to fellow delegates as soon as possible.
2. I ask clarifying questions if I disagree or do not understand.
3. I actively seek feedback from a diverse range of students and promote the mission and goals of the Organization.
4. I only act on behalf of CGS or OSU when I am authorized specifically to do so.

### **6. As a CGS Representative, I value *Responsiveness*. In practice, this value looks like:**

1. I am available to all students and fellow delegates and keep them informed on CGS projects and events.
2. I am ready to respond in a direct and respectful manner to issues that implicate the well-being, justice, and unity of our community.

### **7. As a CGS Representative, I value *Cooperation*. In practice, this value looks like:**

1. I seek to work with others and divide responsibilities on tasks.
2. I encourage new ideas and share all relevant information with others.
3. I strive to reach a consensus that best serves the OSU community.

### **8. As a CGS Representative, I value *Commitment*. In practice, this value looks like:**

1. I continue to pursue worthy goals, regardless of their difficulty.
2. I have a clear set of objectives, a general time-frame for accomplishment, and am willing to see difficult projects through to their completion.
3. I make every effort to recommend potential services when I am unable to fulfill a request.

### **9. As a CGS Representative, I value *Professionalism*. In practice, this value looks like:**

1. I prepare for meetings by reading the necessary materials and arriving on-time.
2. I make guests at meetings feel welcome, and devote my full attention to their presentations.
3. I speak respectfully, without profanity or sarcasm.
4. I approach directly those persons with whom I have a conflict or disagreement.

## **Article XIII - Code of Ethics and Values**

### **10. As a CGS Representative, I value *Service*. In practice, this value looks like:**

1. I make a concerted effort to assist my peers in any capacity.
2. I focus on the needs of the greater student body, with consideration for my own position as a student within that body.
3. I understand my role as a CGS Representative as service to the values articulated in our Constitution.

Guests speakers who are an essential part of the leadership of the graduate school

Dean Osmer (returning to faculty position; SLST – senior advisor) & Assistant Dean Kathy Wallace (liaison & advisor to CGS, oversees GATA award & Preparing Future Faculty program; Hayes forum)

### Address from Dean Osmer:

- approve adoptive leave policy [benefits and support for students]
- Hayes forum is good preparation for professional meeting, provides model for abstract writing and communicating one's research
- Cross-cultural dialogue and global partnerships & collaborations are becoming more important
- Graduate school will be providing workshops & events to supplement core education in program, serves in an advocacy role, and with any life/work issues
- Addressing the challenge of "standard" policies for very different programs

## Questions

**Anderson.2299:** Wonderful advocates for grad. Students – what are challenges for OSU in future?

**Dean Osmer:** There's a lot of change at many levels – in graduate education that impacts funding. Changing notion of education a public or private good. Importance of funding public research universities, changing conception. The impact of globalization – interconnectedness, internet, changes to how we work, live, study and research. Need greater investment in research and graduate education – technical advances; the politics of funding – private sector / fed & state agencies.

**Odden.2:** Regarding the need of quality graduate education, previously graduate students got face time with support services. The problem of consolidation – visibility of professoriate/undergraduates – graduate students don't fit in either. Places we don't reach – graduate school could advocate more, grad. Students have a high need. More and better and attention, for example, on computing resources. Recognize graduate students as distinct & important population?

**Dean Osmer:** Visibility of grad education or lack thereof – core/root of issue. The cost pressures. Departmental level issue – grad. Students advocating for themselves? Kathy Wallace: advise how to go through the process – let them know what working on – might connect with other initiatives. Osmer: support for graduate students – larger issue.

**DasGupta.18:** Recent changes to health insurance plan resulted in higher co-pay for graduate students. Could you shed some more light? Affordable Care Act. Huge jump in the co-pays (\$10-85) in some cases. Students impacted.

**Dean Osmer:** Student Health Insurance Committee working to rectify issue. Once more, need for effective advocacy. There is a huge advocacy effort in place: meeting with IRS, Dept. of Labor etc. There is financial pressure on both faculty/staff plans as well (grad) student plans. Gathering data to make the case against these changes can be very useful and convincing.

Bowers.461: options: go through with election or postpone elections to September meeting

Odden.2: How disruptive to postpone until next month?
